## AMENDMENT TO RESTRICTIONS

RETURN TO - SECURITY TITLE CO.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned owners of the following described property situate in Salt Lake County, Utah, to-wit:

> Lots 1 to 33, inclusive, 35 to 102, inclusive and Lots 104 to 110, inclusive, CROWN COLONY SUBDIVISION, according to the official plat thereof, recorded in the office of the County Recorder of said County.

do hereby amend those certain "Restrictions", recorded November 8, 1960 in Book 1756, page 124 of Official Records as follows:

Paragraph "2" is hereby amended to read as follows:

2. USE OF LAND: BUILDING COST RESTRICTIONS: No structures shall be erected, altered, placed or permitted to remain on any residential building plot other than one family dwelling not to exceed two stories in height and a private garage for not more than four cars.

Paragraph "3" is hereby amended to read as follows:

3. DWELLING SETBACK AND FREE SPACE: No building shallbe located on any residential building plot nearer than 30 feet to the front lot line. No building except a detached garage or other outbuilding located 60 feet or more from the front lot line shall be located nearer than 10 feet to any side lot line, and a total width of the 2 side yards for any one lot will be not less than 24 feet, except in the case of an attached Garage or Carport the total width of the 2 side yards may be 20 feet. No residential structure shall be erected or placed on any building plot, which plot has an area of less than 10000 square feet or a width of less than 80 feet at the front building setback line.
