BEN LOMOND GOLF COURSE, INC., a corporation, AS GRANTOR, hereby conveys and warrants to WEBER BASIN WATER CONSEVANCY DISTRICT, GRANTEE, for the sum of Ten Dollars (\$10.00) and other good and valuable conideration, the following described perpetual easement in the County of Weber, State of Utah, to wit:

Perpetual easement to construct, reconstruct, operate, maintain, install, repair, alter, enlarge, inspect, relocate. replace, move, and otherwise service the facilites listed below, with all rights of ingress and egress, on, over, under, and across lands in a portion of Section 6, Township 6 North, Range 1 West, Salt Lake Base and Meridian, and being particularly described as follows:

WELL PROTECTION ZONE EASEMENT

A one hundred foot radius well protection zone within the Northeast Quarter of Section 6, Township 6 North, Range 1 West, Salt Lake Base and Meridian, U.S. Survey, centered at the location of a well that is South 483.38 feet and East 1,427.77 feet from the North Quarter corner of Section 6, basis of bearing being North 00 deg. 46'49" East between said corner and the center of Section 31, Township 7 North, Range 1 West, and extending from said well in a full and complete circle with a radius of 100 feet total including said well and all property within a 100 foot radius of said well.

PIPELINE & INGRESS/EGRESS EASEMENT 11.019.0001 ABST. ONLY

A pipeline and ingress/egress easement located within the Northeast Quarter of Section 6, Township 6 North, Range 1 West, Salt Lake Base and Meidian, U.S. Survey, described as follows:
