CLINTON L. MILLS and ANN C. MILLS, husband and wife,-----
 of Woods Cross, County of Davis, State of Utah, hereinafter
 referred to as Grantor, hereby conveys to THE UNITED STATES OF AMERICA,
 acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat.,
 388) and acts amendatory thereof or supplementary thereto, Grantee, for
 the sum of One Dollar (\$1.00), a perpetual easement to construct, recon-
 struct, operate and maintain an underground pipeline or pipelines and
 appurtenant structures which latter may protrude above the ground surface
 on, over or across the following described property in Davis County,
 State of Utah:

A strip of land in the Southwest Quarter of the Northwest Quarter
 (SW1/4NW1/4) of Section Twenty-five (25), Township Two (2) North, Range
 One (1) West, Salt Lake Base and Meridian, Twenty (20) feet wide
 and included between two lines extended to the property lines and
 everywhere distant Seven (7) feet on the right or Easterly side and
 Thirteen (13) feet on the left or Westerly side of that portion of
 the following described centerline of what is known as the Woods Cross
 Lateral 2.3R from Station 39+86.0 to Station 45+39.0 measured at
 right angles thereto; said centerline is more particularly described
 as follows:

Beginning at Station 39+86.0, a point on the South line of the Grantor's
 property from which point the Northwest corner of said Section 25 bears
 North 9°13' West Twenty Hundred Fifty-seven and Five-tenths (2057.5)
 feet, and running thence North 9°11' East Five Hundred Fifty-three
 (553.0) feet to Station 45+39.0, a point on the Easterly line of the
 Grantor's property from which point the Northwest corner of said
 Section 25 bears North 15°43' West Fifteen Hundred Forty-two and
 Seven-tenths (1542.7) feet, containing 0.25 of an acre, more or less.

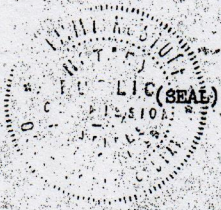
