This contract includes the following:

- 1. Number one name listed will be the Chairman.
2. Numbers two through five will be Co-Chairmen in that order.
3. Numbers six through ten will be Representatives of the five families and will serve as Chairman and Co-Chairmen according to their number, after one through five have served or refuse to serve.
4. When another Chairman takes over-someone should go to each County (with recording data) and make a note on the contract as to who the new Chairman has been chosen. Put dates of those deceased.
5. The Heirs have the responsibility to select representatives for their family. The representative that handles the money for their family should make copies of the statement showing money received and list expenses and give a copy to each Heir entitled to receive money. (This applies to blood lineage)
6. While there are at least two survivors from this original Contract, they should supervise writing a new contract-following this same format with ten names. (The Spouses names will not be necessary.) When the Contract is completed it should be recorded in the four counties. (Include deed, descriptions, and book and page number)
7. To vote for any changes, a majority of three or more votes are necessary. One vote to represent each of the five brothers.
8. The wife of a deceased husband in this contract (one through four) will continue to receive oil money. (When a new contract is written this last rule #8 should be omitted to follow the rule of blood lineage.)

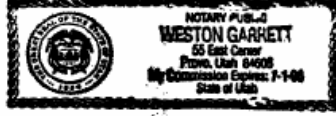
