This divorce action is before the court on **Cynde L Smith's** VERIFIED PETITION FOR DIVORCE. The Court, having accepted the parties' stipulation and found and entered its FINDINGS OF FACT AND CONCLUSIONS OF LAW and being otherwise fully advised, adjudges and decrees as follows:

# DIVORCE

 Verron D Smith has withdrawn any defenses raised in any and all pleadings contesting the divorce and Verron D Smith's default is entered. Cynde L Smith is granted a divorce based on the Affidavit of Jurisdiction and Grounds signed by Cynde L Smith.

# CHILDREN

2. There are no children from this marriage.

# PERSONAL PROPERTY

- 3. The following personal property is divided as indicated:
  - a. Cynde L Smith shall receive the following property:

#### DEBTS

5. The parties are not aware of any debts from the marriage. Should any debts exist, each debt shall be the responsibility of the party incurring the debt.

#### REAL PROPERTY

- 6. During the course of the marriage, the parties acquired the following real property:

  - b. Verron D Smith shall receive sole and exclusive ownership of this property. Cynde L Smith shall receive a share of the equity existing in the property at the date of the entry of the Decree of Divorce. The parties agree that the equity at the date of the divorce is \$20,000.00. Cynde L Smith's share is \$10,000.00. Cynde L Smith shall sign a Quit-Claim deed to Verron D Smith at the time the divorce is entered, but shall retain an equitable lien against the property in the amount of \$10,000.00. Upon Verron D Smith paying the equitable lien amount Cynde L Smith shall sign a second Quit-Claim deed removing the lien from the property.

#### ALIMONY

7. Neither party shall be awarded alimony from the other.

# RETIREMENT MONEY

8. The parties have no interest in any retirement money which is marital property or that they need the court to make an order on.

# DUTY TO SIGN DOCUMENTS WHICH IMPLEMENT DECREE OF DIVORCE

9. Both parties are ordered to sign and fully execute whatever documents are necessary for the implementation of the provisions of their divorce decree. Should a party fail to execute a document within 60 days of the entry of their divorce decree, the other party may bring an Order to Show Cause at the expense of the disobedient party and ask that the Court appoint some other person to execute the document pursuant to Rule 70 of the Utah Rules of Civil Procedure. Any document executed pursuant to Rule 70 has the same effect as if executed by the disobedient party.

10. Cynde L Smith is restored the use of the former name of Cynde Lynne Row.
