DRAINAGE EASEMENT

For the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned GRANTORS hereby grant, convey, sell, and set over unto Layton City Corporation, a body politic of the State of Utah, hereinafter referred to as GRANTEE, its successors and assigns, a perpetual right-of-way and casement to flow storm drain water over the easement property; to lay, maintain, operate, repair, inspect, protect, install, remove and replace storm drain facilities, hereinafter called "Facilities"; and to access adjacent property immediately to the south of GRANTORS' property, including access with such equipment as is necessary for the construction, maintenance, operation, repair, inspection, protection, installation, removal and replacement of GRANTEE'S storm drain facilities situated between GRANTORS' land and Kays Creek; said right-of-way and easement being situated in Layton City, State of Utah, over and through a parcel of the GRANTORS' land, more fully described as follows:

TO HAVE AND TO HOLD the same unto the said GRANTORS, its successors and assigns, with the right of ingress and egress in said GRANTEE, its officers, employees, representatives, agents and assigns to enter upon the above described property with such equipment as is necessary to install, maintain, operate, repair, inspect, protect, remove and replace said Facilities. During construction periods, GRANTEE and its agents may use such portion of GRANTORS' property along and adjacent to said right-of-way as may be reasonably necessary in connection with the construction or repair of said Facilities. The contractor performing the work shall restore all property through which the work traverses, to as near its original condition as is reasonably possible. GRANTORS shall have the right to use said premises except for the purpose for which this right-of-way and easement is granted to the said GRANTEE, provided such use shall not interfere with the Facilities or with the collection and conveyance of storm drainage through said Facilities, or any other rights granted to the GRANTEE hereunder.


