#### SECOND SUPPLEMENTAL ORDINANCE NO. O 20-2004

A SECOND SUPPLEMENTAL ASSESSMENT ORDINANCE amending and supplementing Supplemental Assessment Ordinance No. 99-07 adopted on May 10, 1999; confirming and approving a new assessment list and reaffirming the levying of an assessment against certain properties in Eagle Mountain City, Utah Special Improvement District No. 98-1, Utah County, Utah for the purpose of refinancing the costs of constructing roads, acquiring easements and installing sewer, water, telecommunications, electrical and gas utility improvements, constructing park and landscaping improvements, replacing above ground electric transmission lines with underground electric transmission lines, and completing any miscellaneous work necessary to complete the improvements in a proper and workmanlike manner (the "Improvements"); amending the assessment prepayment provisions; reaffirming the establishment of a Reserve Fund and Stabilization Reserve Fund; establishing the effective date of this Second Supplemental Assessment Ordinance; and related matters.

BE IT ORDAINED BY THE CITY COUNCIL OF EAGLE MOUNTAIN CITY, UTAH COUNTY, UTAH:

Section 1. <u>Approval of Revised Assessment List; Findings.</u> Pursuant to Section 6(c) of Supplemental Assessment Ordinance No. 99-07 (the "Original Assessment Ordinance") adopted by the City Council (the "Council") of Eagle Mountain City, Utah (the "Issuer") on May 10, 1999, the Issuer hereby elects to allocate the assessments originally assessed against the assessed properties pursuant to the initial assessment list attached to the Original Assessment Ordinance in accordance with a new assessment list, a copy of which is attached hereto as Exhibit A and incorporated herein by reference (the "Assessment List"), and hereby confirms that the Assessment List is just and equitable; that each piece of property assessed within the District is benefited in an amount not less than the assessment levied against said property; and that no piece of property listed in the Assessment List will bear more than its proportionate share of the cost of the Improvements.

Section 2. <u>Method and Rate</u>. The Issuer hereby reaffirms the original levy of assessments for the District in accordance with the following method and at the following rates:

Area within the <u>District</u>	<u>Improvements</u>	Assessment	Method of Assessment
The Ranches Subdivisions (those properties within the District located south of State Road 73)	Roads; sewer, water, gas, electric and telecommunications improvements; landscaping; and parks and underground electrical lines	\$11,792.54*	Per developable acre
Meadow Ranch Subdivisions (those properties within the District located north of State Road 73)	Water, gas, electric, and telecommunications improvements; landscaping; and parks and underground electrical lines	\$8,059.34*	Per developable acre

Reaffirmation of Payment of Assessments. Consistent with the Original Section 3. Assessment Ordinance, the remaining assessments shall be payable over a period of nine (9) years from October 15, 2004, in nine (9) substantially equal annual installments including interest on the unpaid balance of the assessment at the same rate as the rate or rates of the special assessment bonds issued by the Issuer with respect to the District, plus one-half of one percent or an amount equal to the annual actual administrative costs to the Issuer for administration of the District, including the preparation and enactment of amendments to the assessment list. accounting costs experienced by the Issuer and the legal fees associated with the administration of the District, whether or not such administrative services are performed by employees of the Issuer or by professional services under contract to the Issuer. The assessment payment dates shall fall on October 15 of each year beginning October 15, 2004, until all assessments have been paid in full. Interest shall accrue from the effective date of this Second Supplemental Ordinance All delinquent assessments that remain due and payable under the Original Assessment Ordinance shall, however, remain due and payable upon such terms, conditions and interest rates as set forth in the Original Assessment Ordinance and nothing in this Second Supplemental Ordinance shall be construed to the contrary.

Section 4. <u>Prepayments of Assessments</u>. Sections 6(b) and (d) of the Original Assessment Ordinance are hereby amended to read as follows:

<sup>\*</sup> Since nondelinquent property owners have made regularly scheduled assessment payments since the initial assessment levy, the Assessment List reflects the current unpaid principal assessment. The assessments of delinquent property owners include all delinquent and unpaid assessments, including accrued but unpaid interest on said delinquent assessments through December 15, 2003.

- (b) A property owner may clear the assessment lien from all or a portion (the "Release Parcel") of its assessed property (the "Assessed Parcel") by prepaying the assessment pertaining to such Release Parcel, as follows:
  - (i) The total acreage of the Release Parcel shall be calculated by adding the total developable acreage to be released plus the acreage of undevelopable property required by the Issuer to be released with respect to the developable property to be released. (The attorney and city engineer for the Issuer shall determine for the Issuer the amount of undevelopable property to be released.) The property owner shall submit the legal description of the Release Parcel which shall include the total developable and undevelopable acreage of said parcel. Undevelopable area contemplated to be used as a golf course shall not, however, be released until not less than 75 acres of developable acres have been released by prepayment of assessment, after which all of the undevelopable area to be used as a golf course shall be released.
  - (ii) The property owner shall prepay an assessment applicable to the Release Parcel calculated as follows: (total developable acreage to be released) x (the applicable assessment per acre set forth in Section 5 of the Original Assessment Ordinance and in Section 2 of the Second Supplemental Ordinance less any regularly scheduled principal assessment payments made with respect to said Release Parcel) x (110%) (or 100% if the property owner is prepaying the assessment on the entire Assessed Parcel).
  - (iii) The treasurer, the attorney and city engineer for the Issuer must determine that the partial release of lien upon payment of the prepayment amount determined under (ii) above does not diminish the security of the Issuer based upon the amount of the assessment due on that portion of the Assessed Parcel after release of the Release Parcel (the "Remaining Assessed Parcel") compared with the amount and value of the Remaining Assessed Parcel remaining to secure such assessment. For purposes of this subparagraph (iii), security of the Issuer will not be considered diminished if the fair market value of the Remaining Assessed Parcel subject to the assessment equals or exceeds three times the remaining unpaid assessment on such Remaining Assessed Parcel. In determining the value of the Remaining Assessed Parcel, the treasurer, the attorney, and the city engineer for the Issuer are entitled to, but need not rely on, credible evidence or documentation presented by the owner of said property.
  - (iv) Any premiums, interest and administrative costs, including administrative costs of the Issuer referenced in Section 3 herein, shall be

determined by the Issuer and must also be paid as part of any prepayment paid pursuant to (ii) above.

Regularly scheduled assessment payments previously made by a property owner do not entitle the property owner to release a Release Parcel without paying the prepayment calculated hereinabove.

Unless the property owner is prepaying all of the assessment on the Assessed Parcel, ninety-one percent (91%) of the principal prepayment made pursuant to this subsection (b) on the Release Parcel shall be applied by the Treasurer to reduce the next succeeding principal assessment installments coming due hereunder. The remaining nine percent (9%) of the principal prepayment shall be deposited in the Stabilization Reserve Fund as described in Section 12 herein. If the property owner is prepaying the assessment on the entire Assessed Parcel, no amounts will be deposited in the Stabilization Reserve Fund.

- (d) To reduce the administrative costs of the District and for other reasons, the City Council hereby determines that in the event title to all or any portion of the property assessed hereunder is voluntarily transferred to another person or entity, the transferor of said assessed property shall be required to prepay that portion of the assessment applicable to the transferred parcel (based upon the calculation described in subsection (b) above). The following transfers shall not, however, require a prepayment of assessment under this subsection (d): (1) a contribution of a parcel of property to the Issuer for an essential governmental function as defined in subsection (c) above and (2) an involuntary transfer resulting from an act of bankruptcy or the exercise of a contractual remedy resulting in the transfer of title.
- Second Supplemental Ordinance, the Issuer anticipates refunding and retiring the Assessment Bonds referenced in the Original Assessment Ordinance by issuing its Special Assessment Refunding Bonds Series 2004A (Special Improvement District No. 98-1) (the "Series 2004A Bonds") pursuant to an Indenture of Trust dated as of September 1, 2004 (the "Indenture"), by and between the Issuer and U.S. Bank National Association, as trustee (the "Trustee"). All references in the Original Assessment Ordinance to the "Assessment Bonds" are hereby amended to the Series 2004A Bonds, all references to the "Bond Resolution" are hereby amended to the Indenture, all references to the "Trustee" are hereby amended to the Trustee under the Indenture, and all references to the Reserve Fund and Stabilization Reserve Fund are amended to refer to the Reserve Fund and Stabilization Reserve Fund established under the Indenture.

Section 6. <u>Amendment to Section 11 of Original Assessment Ordinance</u>. Section 11 of the Original Assessment Ordinance is hereby amended to read as follows:

Section 11. Debt Service Reserve Fund. The Issuer does hereby establish a reserve fund (the "Debt Service Reserve Fund") in lieu of funding a special improvement guaranty fund, as additional security for the Series 2004A Bonds to be issued by the Issuer with respect to the District. The Debt Service Reserve Fund shall be initially funded concurrently with the issuance of the Series 2004A Bonds in an amount equal to ten percent (10%) of the total principal amount of the Series 2004A Bonds, which amount constitutes the "Debt Service Reserve Requirement." Any moneys on deposit in the Debt Service Reserve Fund upon the final payment of the Series 2004A Bonds, shall be applied by the Trustee first, to the final unpaid assessment payment obligation of the Assessed Parcels to the extent that the assessments on said Assessed Parcels were the source of funding of the Debt Service Reserve Fund, and second, to the owners of record of those properties, the assessment on which was the source of funding of the Debt Service Reserve Fund as an excess assessment payment, provided, however, that no payment shall be made with respect to property, the assessment on which is in default or not otherwise fully paid.

In the event insufficient assessments are collected by the Issuer to make the debt service payments on the Series 2004A Bonds, the Issuer shall draw on the Debt Service Reserve Fund to make up such deficiency. In the event the amount on deposit in the Debt Service Reserve Fund is less than the Debt Service Reserve Requirement, the Issuer shall replenish the Debt Service Reserve Fund as provided in Section 12 herein and in the Indenture authorizing the issuance of the Series 2004A Bonds. If the amount on deposit in the Debt Service Reserve Fund exceeds the Debt Service Reserve Requirement, excess moneys shall be transferred to the Bond Fund established under the Indenture to be applied pro rata against the next assessment payment obligation coming due.

If there are insufficient moneys on deposit in the Debt Service Reserve Fund after all available moneys in the Stabilization Reserve Fund have been transferred to the Debt Service Reserve Fund as provided in Section 12 herein, the Issuer agrees to deposit in the Debt Service Reserve Fund, on or prior to the next payment date on the Series 2004A Bonds, moneys as provided in the Indenture in amounts sufficient to replenish the Debt Service Reserve Fund to the Debt Service Reserve Requirement and to pay on a timely basis any debt service payments falling due on the Series 2004A Bonds on the next succeeding payment date.

Section 7. <u>Amendment to Section 12 of the Original Assessment Ordinance</u>. Section 12 of the Original Assessment Ordinance shall be amended to read as follows:

Section 12. <u>Stabilization Reserve Fund.</u> To provide additional security for the payment of assessments hereunder and to assure the marketability of the

Series 2004A Bonds, the Issuer does hereby establish a special stabilization reserve fund (the "Stabilization Reserve Fund"). The Stabilization Reserve Fund shall be initially funded concurrently with the issuance of the Series 2004A Bonds in an amount of not less than \$100,000. Thereafter, except for prepayments of the assessment on the entire Assessed Parcel, all prepayments collected by the Issuer constituting nine percent (9%) of the principal prepayment referenced in Section 6(b)(ii) of the Original Assessment Ordinance, as amended, on the Release Parcel shall be deposited in the Stabilization Reserve Fund. Moneys, if any, in the Stabilization Reserve Fund shall be transferred by the Trustee (A) to the Debt Service Reserve Fund to the extent there is not on deposit therein the Debt Service Reserve Requirement, and/or (B) so long as the Debt Service Reserve Fund is fully funded to the Debt Service Reserve Requirement after payment in full of the current principal and interest payment on the Series 2004A Bonds, to the Bond Fund established under the Indenture in the event an assessment listed in the Assessment List attached hereto as Exhibit A is paid in full whether at maturity or upon earlier prepayment, and applied against said final assessment payment, provided that the amounts transferred from the Stabilization Reserve Fund to the Bond Fund shall not exceed the total of all prepayment amounts paid into and remaining in the Stabilization Reserve Fund by the owner who has paid his/her assessment in full. In the event the Debt Service Reserve Fund is drawn on to make debt service payments on the Series 2004A Bonds, the Trustee shall replenish the Debt Service Reserve Fund to the Debt Service Reserve Requirement with moneys on deposit in the Stabilization Reserve Fund.

Section 8. <u>Amendment to Section 13 of Original Assessment Ordinance</u>. Section 13 of the Original Assessment Ordinance is hereby amended to read as follows:

Section 13. All investment earnings on the Debt Service Reserve Fund and the Stabilization Reserve Fund shall be maintained in said Funds respectively and applied in the same manner as the other moneys on deposit therein as provided in the Indenture.

Section 9. <u>Contestability</u>. No assessment shall be declared void or set aside in whole or in part in consequence of any error or irregularity which does not go to the equity or justice of the assessment or proceeding. Any party who has not waived his objections to same as provided by statute may commence a civil action against the Issuer to enjoin the levy or collection of the assessment or to set aside and declare unlawful this Second Supplemental Ordinance.

Such action must be commenced and summons must be served on the Issuer not later than 30 days after the effective date of this Second Supplemental Ordinance. This action shall be the exclusive remedy of any aggrieved party. No court shall entertain any complaint which the party was authorized to make by statute but did not timely make or any complaint that does not go to the equity or justice of the assessment or proceeding.

After the expiration of the 30-day period provided in this Section 9:

- (a) The Series 2004A Bonds and the assessments levied in the District shall become incontestable as to all persons who have not commenced the action provided for in this Section 9; and
- (b) No suit to enjoin the issuance or payment of the Series 2004A Bonds, the levy, collection or enforcement of the assessment, or in any other manner attacking or questioning the legality of the bonds or assessments may be instituted in this state, and no court shall have authority to inquire into these matters.
- Section 10. <u>Notice to Property Owners</u>. The Treasurer is hereby authorized and directed to give notice of assessment by mail to the property owners in the District. Said notice shall, among other things, state the amount of the assessment and the terms of payment. A copy of the form of notice of assessment is available for examination upon request at the office of the City Recorder.
- Section 11. <u>All Necessary Action Approved</u>. The officials of the Issuer are hereby authorized and directed to take all action necessary and appropriate to effectuate the provisions of this Second Supplemental Ordinance.
- Repeal of Conflicting Provisions; Reinstatement of Original Assessment Section 12. Ordinance. All ordinances or parts thereof in conflict with this Second Supplemental Ordinance are hereby repealed. Notwithstanding anything contained herein to the contrary, all prepayment assessment amounts paid on or before July 14, 2004, shall be calculated and determined by the Issuer in accordance with Section 6 of the Original Assessment Ordinance as though said Section had not been amended pursuant to Section 4 of this Second Supplemental Ordinance. facilitate the issuance of the Series 2004A Bonds, the Issuer shall not accept any prepayment of assessments from July 15, 2004, through September 1, 2004. In the event the Issuer fails to issue the Series 2004A Bonds on or before September 1, 2004, Sections 4, 5, 6, 7 and 8 of this Second Supplemental Ordinance shall automatically be repealed, and the terms and conditions of Sections 6(b), 11, 12 and 13 of the Original Assessment Ordinance shall be reinstated as of September 1, 2004, and the Issuer and the Trustee shall give written notice to each owner of assessed property, together with a summary of said owner's assessment obligation. In the event the Series 2004A Bonds are issued on or before September 1, 2004, all provisions of this Second Supplemental Ordinance shall remain effective as of its effective date.
- Section 13. <u>Publication of Ordinances</u>. Immediately after its adoption, this Second Supplemental Ordinance shall be signed by the Mayor and City Recorder and shall be recorded in the ordinance book kept for that purpose. This Second Supplemental Ordinance shall be published once in the <u>New Utah News</u>, a newspaper having general circulation within the boundaries of the Issuer, and shall take effect on said publication date.
