DECREE OF DIVORCE

Having entered Findings of Fact and Conclusions of Law, the Court now hereby orders, adjudges and decrees as follows:

- 1. Petitioner is hereby awarded a Decree of Divorce from Respondent which dissolves the bonds of matrimony between them.
 - 2. The parties have no children together, and none are expected.
 - 3. Petitioner, "Greg" is employed full-time.
 - 4. Respondent, "Monica" is employed full-time.
- 5. Neither party has the need for alimony, and both parties are able to earn sufficient for their needs.
- 6. The parties own a home together, located in Draper, Utah. The parties are currently under contract to sell the home. All proceeds from the home shall be awarded to Greg.
- 7. As part of this global settlement, Greg shall be awarded the following personal property: His truck, the boat, the snowmobile, the Marlon Sled Deck, the home

furnishings, and his personal belongings. Monica shall be awarded: her car and her personal belongings. If there is a debt secured by the personal property, the party awarded the personal property shall be responsible for that debt, and shall hold the other party harmless thereon.

- 8. Each party shall be awarded the 401(k) and any other retirement accounts in his or her name. If there is a debt on the retirement account, the debt shall remain with the account and shall be the obligation of the party to whom the account was awarded. Additionally, each party shall be awarded his or her separate bank accounts. The parties have a joint bank account at Mountain America Credit Union, and that account shall be divided 50/50 between the two parties.
- 9. Each party shall waive his or her claim on the other party's retirement account and pension plans.
- 10. During the course of the parties' marriage, the parties have incurred certain obligations listed below. The parties agree to split those debts 50/50 between the two parties.

11. Each party shall execute and deliver to the other all instruments of transfer and documents of ownership required to perform such party's obligations hereunder, and each party shall provide continuing assurance, upon reasonable request, of compliance with all of the provisions hereof. The parties shall cooperate reasonably with each

other, in person or through counsel, to carry out all provisions of herein.

- 12. The parties shall take all necessary steps to remove each other's name from any and all joint accounts or obligations within thirty (30) days of the entry of the Decree of Divorce herein, including all requirements and notices set forth in UTAH CODE ANN. §§ 30-3-5, 15-4-6.5 and 15-4-6.7.
 - 13. Each party shall pay their own attorney fees.
 - 14. Respondent shall be restored to her maiden name if she so desires.
