AMENDMENT TO BUILDING RESTRICTIONS

RIVIERA HEIGHTS NO. 1 SUBDIVISION

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, owners of the following described real property in Salt Lake County, Utah:

> All of Lots One (1) through Fourty-Five (45), inclusive, in RIVIERA HEIGHTS NO. 1 SUBDIVISION, according to the official plat on file and of record in the office of the County Recorder of said County.

hereby amend and modify those certain building restrictions recorded October 30, 1963 as entry number 1956458, in Book 2117 at page 32 of the official records of Salt Lake County as follows:

Paragraph D is amended to read as follows: "No building shall be located on any lot nearer than 30 feet to the front lot line, or nearer than 20 feet to any side street line. No building shall be located nearer than 8 feet to an interior lot line, except that no side yard shall be required for a garage or other permitted accessory building located 45 feet or more from the minimum building setback line. No dwelling shall be located on any interior lot nearer than 25 feet to the rear lot line. For the purposes of this Covenant, eaves, steps, and open porches shall not be considered as part of a building, provided, however, that this shall not be construed to permit any portion of a building on a lot to encroach upon another lot."

Paragraph H is amended to read as follows: "No structure, of a temporary character, trailer, basement, tent, shack, garage, barn or other out-building shall be used on any lot at any time as a residential lot herein-before described or any part thereof."

Paragraph K, line 21, the date is hereby changed from January 1, 1975 to January 1, 1994.

Paragraph L is amended to read as follows: "These covenants are to run with the land and shall be binding on all parties and all persons claiming under them for a period of thirty years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive periods of 10 years unless an instrument signed by a majority of the then record owners of the lots has been recorded, agreeing to change said covenants in whole or in part.
