DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS AND RESERVATION OF EASEMENTS FOR PEREGRINE POINTE SUBDIVISION (PHASE 1A)

PREAMBLE

This Declaration of Covenants, Conditions and Restrictions and Reservations of Easements for Peregrine Pointe Subdivision (Phase 1) affects the following real property located in Washington County, State of Utah:

Phase I - See Exhibit A attached hereto and incorporated herein.

The terms contained in this Preamble and the Recitals below, which are hereafter defined in Article, shall be given the meaning assigned to them in Article I.

RECITALS

- A. Declarant Peregrine Partners, L.L.C. will develop the real property described in Exhibit A as a residential planned unit development.
- B. The Declarant hereby declares that all of the Property shall be maintained, held, sold, conveyed encumbered, hypothecated, leased, used, occupied and improved subject to the following easements, restrictions, reservations, rights, covenants, conditions and equitable servitudes, all of which are for the purpose of uniformly enhancing and protecting the value, attractiveness and desirability of the Property, in furtherance of a general plan for the protection, maintenance subdivision, improvement, and sale of the Property or any portion thereof. If any portion of a Dwelling Unit or other Improvement constructed by Declarant, or if any portion of a Divelling Unit or other Improvement reconstructed so as to substantially duplicate the Dwelling Unit or other Improvement originally constructed by Declarant, encroaches upon the Common Areas or other Lots, as a result of the construction, reconstruction, repair, shifting, settlement or movement of any portion of the Property, a valid easement for the encroachment and for the maintenance of the same shall exist so long as the encroachment exists.

2.10 Covenant to Occupy. By acceptance of a deed or other form of conveyance of a Lot from Declarant, the first Owner of a Lot, his successors or assigns, shall occupy the Lot as the Owner's primary, winter, or vacation home for EIGHPEEN (18) months from the date of recording of a deed. Such an Owner does hereby covenant that at no time during the Covenant to Occupy period will such Owner rent or lease the Lot to any other person, nor shall the Owner allow any person, or persons, to occupy the subject property in Owner's absence.

Owner further acknowledges (i) that Declarant has incurred extraordinary expense in developing the Property as a residential community – not a rental project; (ii) that rental of homes in violation of this Covenant to Occupy will have an adverse effect upon Declarant; (iii) that Declarant's damages are difficult to measure or incapable of accurately estimating; and (iv) that the liquidated damages provided for herein are reasonable. By acceptance of a deed the Owner warrants that Owner, his successors and assigns, will honor the Covenant to Occupy. Therefore, should such Owner, his successors or assigns, violate the Covenant to Occupy, Owner and his successors and assigns, shall be liable to the Declarant for liquidated damages in the amount of \$4,000.00. Declarant's right to liquidated damages shall be in addition to equitable actions for specific performance and injunctive relief. Declarant shall be entitled to all costs, expenses and reasonable actionney's fees in any action to recover liquidated damages and/or to enforce this Covenant to Occupy.

Nothing herein contained shall prevent such an owner from conveying (selling) the property conveyed by this deed, at any time. However, this Covenant to Occupy shall survive any such conveyance and remain an encumbrance on title until the Expiration Date defined below.

- Termination of Covenant to Occupy. The Covenant to Occupy for each Lots shall expire one (1) year from the recording of the deed to the first Non-Declarant Owner to that lot, and shall thereafter have no further force or effect (the "Expiration Date").

ARTICLE IV

VOTING RIGHTS

- Vote Distribution. The Association shall have the following two classes of voting membership:
 - (a) <u>Class A</u> Class A Members shall be all the Owners. Class A Members shall be entitled to one work for each Lot which the interest required for Membership, in the Association is held. In no event, however, shall more than one Class A vote exist with respect to any Lot.
 - (b) <u>Class B</u>. The Class B member is the Declarant. The Class B member is entitled to three (3) votes for each Lot owned. The Class B membership will cease and be converted to Class A membership on the happening of either of the following events, whichever occurs earlier:
 - (i) upon conveyance of seventy-five percent (75%) of the Lots subject to this Declaration to purchasers; or
 - the expiration of seven (1) years from the first Lot conveyance to a purchaser; or
 - (iii) written termination given by Declarant.
- Multiple Ownership. In the event there is more than one Owner of a particular Lot, the vote relating to such Lot shall be exercised as such Owners may determine among themselves. A vote cast at any Association meeting by any-of such Owners, whether in person or by proxy, shall be conclusively presumed to be the vote attributable to the Lot concerned, unless an objection is immediately made by another Owner of the same Lot. In the event such an objection is made, the vote involved shall not be counted for any purpose whatsoever, other than to determine whether a quorum exists.

ARTICLE V

JURISDICTION OF ASSOCIATION

The Association has been organized to provide for the operation, maintenance, preservation and architectural control of the Property and Improvements, to administer the Common Areas of the Association, and to reasonably regulate the Members of the Association. The Association shall have jurisdiction and authority over the Property and the Members of the Association to the full extent allowed by law and also as provided for in this Declaration and in the Articles, Bylaws, and Raise and Regulations, as such documents may be modified from time to time.

ARTICLE VI

COVENANT FOR ASSESSMENTS

Creation of Assessment Obligation. Each Owner of any Dot by acceptance of a deed therefor, whether or not it shall be so expressed in such deed, is deemed to covenant and agree to pay to the Association (1) Annual Assessments for Common Expenses, (2) Special Assessments, (3) Corrective Assessments, and (4) any other amount or assessment levied by the Board pursuant to this Declaration; all such assessments to be established and collected as provided in this Declaration. The Association shall not levy or collect any Annual Assessment, Special Assessment of Corrective Assessment that exceeds the amount necessary for the purpose or purposes for which it is levied. All such assessments, together with interest, costs and reasonable attorneys' fees for the collection thereof, shall be charge on the Lot and shall be a continuing lien upon the Lot against which such assessment is made. Each such assessment, together with interest, costs and reasonable attorneys' fees, it applicable, shall also be and remain the personal obligation of the Person who was the Owner Such property at the time when the assessment fell due. This personal obligation cannot be avoided by abandonment of a Dot or by an offer to waive use of the Common Area. The personal obligation for delinquent assessments liability shall not pass to any new Owner ("Purchaser") successors in title unless expressly assumed by such Rurchaser. For the purpose of assessment, the term "Owner" shall exclude the Declarant, builder, contractor, investor, or other person or entity who purchases a Lot for the purpose of constructing improvements thereon for resale to an Owner, who shall pay no assessment unless a unit constructed on a Lot is occupied for a permanent residence, provided that the Declarant or its assigns shall have the obligation to subsidize the Association until control of the Association passes to the Owners. Subsidization shall be defined as the payment of the reasonable cash needs of the Association for ordinary and necessary maintenance expenses (not) including reserves or capital replacement). The determination of the reasonable cash needs for ordinary and necessary maintenance expenses shall be within the sole discretion of the Board and Declarant shall have no Pability to the Association if subsequent Boards shall disagree with the determination of the Board which made such determination. In no event, however, shall the subsidy exceed the monthly assessments.

Purpose of Annual and Special Assessments. The Annual and Special Assessments levied by the Association shall be used exclusively to promote the common health, safety, benefit

and welfare of the Owners and for the improvement and maintenance of the Common Area, including establishing and funding a reserve to cover major repair or replacement of Improvements within the common Area and any expense necessary or desirable to enable the Association to perform or fulfill its obligations, functions, or purposes under this Declaration or its Articles.

- Annual Assessments. Annual Assessments shall be used to satisfy Common Expenses of the Association, as provided herein and in the Bylaws. The initial Annual Assessment shall be Six Hundred Dollars (\$600.00), payable in twelve (12) equal monthly installments due on the first day of each month. The Annual Assessment shall be based upon the Budget prepared by the Board. The Common Expenses of the Association, and therefore the Annual Assessment, may increase because of, among other reasons, Common Facilities constructed in the sole discretion of Declarant. Nothing herein shall obligate Declarant to construct any Common Facilities. Late fees shall commence at \$30 per month and may be changed by resolution of the Board.
- Special Assessments. In addition to the Annual Assessment a Special Assessment can be assessed to pay the costs of any one or more of the following:
 - Approved by Board. Special Assessments for the following extraordinary expenses can be legged by the Board without Member approval:
 - An extraordinary expense required by an order of a court and
 - An extraordinary expense necessary to repair or maintain the Common Area or any portion thereof for which the Association is responsible where a threat to personal safety on the Common Area is discovered. River to the imposition or collection of a Special Assessment pursuant to this subsection, the Board shall pass a resolution containing written findings as to the necessity of the extraordinary expense involved and why the expense was necessary and was not or could not have been reasonably foreseen in the budgeting process. The resolution shall be distributed to the Members with the notice of Assessment.
- 6.5 Uniform Rate of Assessment. Annual Assessments and Special Assessments imposed pursuant to subsections 6.2, 6.3, and 6.4(a) and (b) of this Declaration shall be assessed equally and uniformly against all Owners and their Lots
 - Date of Commencement of Annual Assessments. The Board shall authorize and lev the amount of the Annual Assessment upon each Lot, as provided herein, by a majority vote of the Board. Annual Assessments shall commence on all Lots on the first day of the first calendar month following the first Close of Escrow for the sale of a Lot in the Property. The first Annual Assessment shall be adjusted according to the number of months remaining in the Fiscal Year as set forth in the Bylaws. The Board shall fix the amount of the Annual Assessment against each Lot at least thirty (30) days in advance of each Annual Assessment period. Written notice of any change in the amount of any Annual Assessment shall be sent to every owner subject thereto, not less than thirty (30) days prior to the effective date of such change. Association shall, upon demand, and for a reasonable charge, furnish a certificate signed by an officer or agent of the Association, setting forth whether the assessments on a specified Lot have been paid. Corrective Assessments and any Special Assessments, the Association may levy Corrective Assessments against a particular Owner and his Lot to pay the following: costs directly attributable to, or reimbursable by, that Owner, equal to the costs incurred by the Association for corrective action, performed pursuant to the provisions of this Declaration, including without limitation Sections 2.9, 8, 7, 2.1, 14.9, and Article XI, plus interest and other charges on sach Corrective Assessments.

The Board shall deliver a Notice of Noncompliance by the Board and Right to Hearing to the Owner upon whom it intends to levy a Corrective Assessment. Corrective Assessments shall be due and payable within (45) days following delivery of Notice of Board Adjudication and shall bear interest thereafter at the rate of eighteen percent (18%) per annum until paid in full.

- Exempt Property The following property subject to this Declaration shall be exempt 6.8 from the assessments herein:
 - All portions of the Property dedicated to and accepted by a local public authority; and
 - (b) The Common Area owned by the Association in fee.
- Notice of Members Meetings; Quorum Requirements. Before any Special Assessment is levied, the Board shall deliver a Notice of Members Meeting. The quorum required For any action authorized by Section 6.4(b) shall be as follows: at the first meeting called the presence of Members or proxies entitled to cast fifty percent (50%) of all outstanding votes shall constitute a quorum. Ma quorum is not present at any meeting another meeting may be called by the Board issuing a Notice of Members Meeting at which a quorum shall be one-half of the quorum which was required at such preceding meeting. No such subsequent meeting shall be held more than forty-five (45) days following such preceding meeting at which a quorum was not present.
- Additional Assessments. In addition to the annual assessments, special assessments, and corrective assessments, the Association shall levy such additional assessments as may be necessary from time to time for the purpose of repairing and restoring the damage or disruption resulting to the Common Areas from the activities of the City of Hurricane in maintaining, regaining or replacing the City's willity lines and facilities thereon.
- 6.11 Preparation of Budget. The Board shall prepare a Budget to be presented to the Members at the annual meetings of the Members held as provided in the Bylaws.

ARTICLE VII

NONPAYMENT OF ASSESSMENTS; REMEDIES

- Nonpayment of Assessments; Remedies. Pursuant to Utah Code Ann. §§ 57-8a-101, any assessment installment payment not et seq. (2004), any assessment installment payment not paid when due shall, together with the hereinafter provided for interest and costs of collection be, constitute, and remain a continuing lien on the Lot provided however, that any such lien will be subordinate to the lien or equivalent security interest of any Mortgage on the Lot recorded prior to the date any such installment payment on assessments become due. If a monthly installment payment is not timely made, the Board may declare the entire Annual Assessment in default and accelerate the Annual Assessment and declare the entire amount of the Annual Assessment immediately due and owing ?
- Washington County Tax Collection. It is recognized that under the Charter the Association will own the Common Area and that it will be obligated to pay property taxes to Washington County. It is further recognized that each Owner of a Lot is a Member of the Association and as part of his assessment will be required to pay to the Association his program share of such taxes. Notwithstanding anything to the contrary contained in this Charter, or otherwise, Washington County shall be, and is, authorized to collect such pro rata share (on an equal basis) of taxes directly from each Owner by inclusion of said share with the tax levied on each Lot. To the extent allowable, Washington County is hereby directed to do so. In the even that the assessor shall separately assess Common Areas to the Association, the Board may impose, in its discretion a Special Assessment to pay such taxes, or they may be incorporated into the Annual Assessment.
- 7.3 Lien. The Board may elect to file a claim of hen against the Lot of the delinquent Owner by Recording a notice ("Notice of Lien") setting forth (a) the amount of the claim or delinquency, (b) the interest and costs of collections which have accrued thereon (c) the legal description of the Lot against which the lien is claimed, and (d) the name of the Owner thereof. - Trust Deed for Assessments. For purposes of this Section and Utah Code Ann. §§ 57-1-19, et seq., as amended from time to time. The Trustee shall mean the attorney for the Association and the Association may provide notice and disclosure of the Trustee by recording an "Appointment of Trustee" on the records of the Washington County Recorder. - 7.5 Perfection of Lien and Priority. Upon the recording of Notice of Lien by the Manager or Board, such lien constitutes a lien on the Lot Owner's interest in the property prior to all other liens and encumbrances, recorded or unrecorded, except.
 - (a) tax and special assessment liens on the Lot in favor of any assessing lot or special improvement district; and
 - (b) encumbrances on the interest of the Lot Owner;
 - (recorded prior to the date of the recording of Notice of Lien; and
 - that by law would be a lien prior to subsequently ecorded encumbrances.

The Manager or Board may enforce the assessment lien by sale or foreclosure of the Owner's interest. The Manager or Board may bid at a sale or foreclosure and hold, lease, mortgage, or convey the Equitar is subject to the assessment lien.

Future Lease Payments. If the Owner of a Lot who is leasing the Lot fails to pay and assessment for more than sixty (60) days after the assessment is due, the Board, upon compliance with this Section, may demand that the tenant pay to the Association all future lease payments due to the Owner, beginning with the next monthly or other periodic payment, until the amount due to the Association is paid. The Manager or Board shall give the Owner written notice of its intent to demand full payment from the tenant under this Section. Individual Board members may also serve as ACC members.
- ACC General Powers. The ACC shall have the right and duty to promulgate 8.2 reasonable standards against which to examine any request made pursuant to this Article, in order to ensure that the proposed Plans conform harmoniously to the exterior design and existing materials of the Improvements on the Property. This power shall include the power to issue ACC Rules and Regulations which, among other provisions, may set forth procedures for the submission of Plans for approval, and state additional factors which it will take into consideration in reviewing submissions.
- Review of Rians and Specifications. The ACC shall consider and act upon any and 8.3 all Plans and specifications submitted for its approval under this Declaration and perform such other duties as from time to time shall be assigned to by the Board, including the inspection of construction in progress to assure its conformance with Plans and specifications approved by the ACC. No exterior construction, alteration, removal, relocation, repainting, demolition, addition, modification, external decoration or redecoration, or reconstruction of a Dwelling Unit or Improvement, including landscaping, in the Property shall be commenced or maintained, until the Mans and specifications therefor showing the nature, kind, shape, height, width, color, materials and location of the same shall have been submitted to the ACC (together with such fees for review and inspection as may be reasonably required by the ACC) and approved in writing by the ACC. The ACC shall approve Plans and specifications submitted for its approval only if it deems that the construction, alterations or additions contemplated thereby in the locations indicated will not be detrimental to the appearance of the surrounding area or the Property as a whole, that the appearance of any structure affected thereby will be in harmony with the surrounding structures, and that the construction thereof will not detract from the beauty, wholesomeness and attractiveness of the Lots

- 8.4 Meetings of the ACC. The ACC shall meet from time to time as necessary to perform its duties hereunder. The vote of a majority of the ACC, shall be sufficient to enact resolutions or motions of the ACC. The attendance of a majority of the members at any meeting shall constitute a quorum.
- 8.5 No Waiver of Future Approvals. The approval by the ACC of any proposals or Plans for any work done or proposed or in connection with any other matter requiring the approval and consent of the ACC, shall not be deemed to constitute a waiver of any right to withhold approval or consent as to any similar proposals, Plans or matters subsequently or additionally submitted for approval or consent.
- Compensation of Members. The members of the ACC shall receive no compensation for services rendered, other than reimbursement for expenses incurred by them in the performance of their duties hereunder.
- Limitation on Liability. Neither the ACC, the Board nor Declarant, nor any member 8.7 thereof, acting in good faith shall be liable to the Association or to any owner for any damage, loss, or prejudice suffered or claimed on account of (i) the approval or rejection of, or the failure to approve or reject, any Plans, drawings, specifications, or variance requests (ii) the construction or performance of any work, whether or not pursuant to approved Plans, (iii) the development or manner of development of any of the Property, or (iv) any engineering or other defect in approved Plans, drawings and specifications.
- Declarant's Rights. The Declarant shall not be required to comply with the provisions in the initial construction of the Property. of this Article in the initial construction of the Property.

ARTICLE

MAINTENANCE AND REPAIR OBLIGATIONS

Maintenance Obligations Owners. It shall be the duty of each Owner, at his sole cost and expense, subject to the provisions of this Declaration requiring ACE Approval, to maintain, repair, replace and restore the Dwelling Unit, Party Wall, and Improvements located on his Lot, and to ensure that the Lot itself is maintained in a neat, sanitary and attractive condition. If any Owner shall permit any Dwelling Unit, Party Wall, or Improvement, the maintenance of which is the responsibility of such Owner, to fall into disrepair or to become unsafe, unsightly or unattractive or to otherwise violate this Declaration, the Board shall have the right to seek any remedies at law or in equity which it may have. In addition, the Board shall have the right, but not the duty, to enter upon such Owner's Lot to perform such emergency and non-emergency repairs or maintenance as the Board deems appropriate and to charge the cost thereof to the Owner. Said cost shall be a

Corrective Assessment enforceable as set forth in this Declaration. For non-emergency repairs or maintenance the Owner shall be entitled to Notice of Noncompliance by the Board and Right to Hearing.

Maintenance Obligations of Association. The Association shall provide for the maintenance, planting, as applicable, repair, and replacement of the Common Area. The Association shaft ensure that the landscaping on the Common Area is maintained free of weeds and disease. The Association shall be authorized, but shall not be required, to maintain any lands within the Property which have been dedicated to and accepted for maintenance by a state, local or municipal governmental agency or entity. All of the foregoing obligations of the Association shall be discharged when and in such manner as the Board shall determine in its judgment to be appropriate.

9.3 Party Walls.

- General Rules of Law to Apply. Each wall which is built as a part of the original construction of the Dwelling Units upon the Property and placed on the dividing line between the Lots shall constitute a party wall, and, to the extent not inconsistent with the provisions of this Article the general rules of law regarding party walls and liability for property damage due to negligence or willful acts of omissions shall apply thereto.
- Sharing of Repair and Maintenance. The cost of reasonable repair and maintenance of a party wall, including perimeter walls, shall be shared by the Owners who make use of the wall in proportion to such use, or the Owner of the wall even if there is no wall in common.
- Destruction by Fire or Other Casualty. If a party wall is destroyed or damaged (c) by fire or other casualty then, to the extent said destruction or damage is not covered by insurance and repaired out of the proceeds of the same, any Owner who has used the wall may restore it, and if the other Owners thereafter make use of the wall, they shall contribute to the cost of restoration thereof in proportion to such use without prejudice, however, to the right of any such Owners to call for a larger contribution from the others under any rule of law regarding liability for negligent or willful acts or omissions.
- Weatherproofing Notwithstanding any other provision of this Article, an Owner who by his negligent or will ful act causes the party wall to be exposed to the elements shall bear the whole cost of furnishing the necessary protection against such elements to the extent that said protection is not covered by insurance and paid for out of the proceeds of the same.
- Right to Contribution Runs With Land. The right of any Owner to contribution from any other Owner under this Article shall be appurtenant to the land and shall pass to such Owner's successors in title.

Should any party refuse to appoint an arbitrator within ten (10) days after written request to do so, the Board of Directors of the Association shall select an arbitrator for the refusing party.
 - 9.4 Perimeter Walls. The Association shall not be obligated to maintain any walls in the Project. Walls dividing a Lot and Common Area shall be maintained by the Owner of the Lot
 - Mold. Whether or not you as an Owner experience mold growth depends to a great 9.5 extent on how you manage and maintain your Dwelling Unit. You are hereby given notice to take all reasonable means to detect and prevent growth and infestation of mold and other similar agents. The Declarant will not be responsible for any damages, and as Owner you waive any claim to damages caused by mold, or by some other agent, that may be associated with customary construction practices in the area, to include but not be limited to property damage, personal injury, loss of income, emotional distress, death, loss of use, loss of value, and adverse health effects, or any Other effects or losses. Any implied warranties, including but not dimited to an implied warranty of workmanlike constructions an implied warranty of habitability, an implied warranty of merchantability or an implied warranty of fitness for a particular purpose, are hereby waived and disclaimed by you as the Owner.

ARTICLE X

#SE RESTRICTIONS

All real property within the Property shall be held, used and enjoyed subject to such limitations and restrictions set forth below.

- Single Family Residence. Subject to the provisions of Section 10.2, each Lot shall be used as a residence for a single family, except as may be authorized below.
- 10.2 Business or Commercial Activity. Subject to the following exceptions, no part of the Property shall ever be used or caused to be used or allowed or authorized to be used in any way, directly or indirectly, for any business, commercial, manufacturing, mercantile, storage, vending or other such nonresidential purposes without the prior written approval of the Board; provided however, that the Declarant, its successors and assigns, may use any portion of the Property for a model home site, display and sales office in connection with the sale of Lots on the Property by Declarant. Occupations without external evidence thereof, including, without limitation, traffic generation, which are merely incidental to the use of the Dwelling Unit as a residential home and for so long as such occupations are conducted in conformance with all applicable governmental ordinances shall be permitted.

Except for one professional quality "For Rent" or "For Sale" sign of not more than four (4) square feet, no advertising signs, billboards, objects of unsightly appearance, or nuisances shall be erected, placed, or permitted to remain on any Lot. Such sign shall not be placed on the Common Areas, but shall be placed in the window of a Dwelling Unit. No commercial activities of any kind whatever shall be conducted in any building or on any portion of the Property. The foregoing restrictions shall not apply to the commercial activities, signs and bill boards, if any, of the Declarant or its agents during the construction and sales period or by the Association in furtherance of its powers and purposes set forth hereinafter and in its Articles of Incorporation, Bylaws and Rules and Regulations, as the same may be amended from time to time
 - Quiet Enjoyment. No noxious or offensive activity or noise shall be carried on upon 10.4 any part of the Property, nor shall anything be done thereon which may be or may become an annoyance or nuisance to the neighborhood, or which shall in any way interfere with the quiet enjoyment of each of the Owners or which shall in any way increase the rate of insurance.
 - Parking for Vehicles and Recreational Vehicles. In order to prevent unsafe and unsightly vehicles from being parked on the street for long periods of time, no Vehicles, Recreational Wehicles other similar vehicles shall be parked or stored on Lot of on a public street or rights of way within the Property for more than forty-eight (48) fours in any seven (7) day feriod. Notwithstanding the foregoing, such vehicle(s) may be stored on a Lot as long as it is stored in a garage. Vehicles and Recreational Vehicles that are inoperable shall not be permitted on the Property. No Vehicle or Recreational Vehicle, or any portion thereof, shall be dismantled, rebuilt, serviced, repaired or painted on any Lot, unless performed completely within an enclosed garage or other approved structure located on the Lot which screens the sight and sound of such activity from the streets and adjacent Lots. The Board may enforce this provision by giving notice to the Owner of the violation, or when the Owner is not readily available, by giving notice in the form of a written request placed on the vehicle in question and subsequently by notifying proper
 - city authorities. Unless otherwise approved by the Board no commercial business equipment is allowed in the Property, other than temporary work equipment required solely for the building of homes.
 - Animals. No animals, livestock or poultry of any kind shall be raised, bred or kept 10.6 on any of said Lots, except that dogs, cats, birds or other household pets may be kept in accordance with City of Hurricane Ordinances; provided that they are not kept, bred or maintained for any commercial purpose.
 - Construction. Construction of Dwelling Units shall be diligently pursued to substantial completion which generally shall occur within lifteen (15) months of commencement, subject to extensions by the ACC in its sole discretion. And damage caused by construction activity (including construction related vehicles), shall be promptly repaired by the Owner or his contractor.

- Temporary Buildings. No outbuilding, tent, shack, shed or other temporary building 10.8 or Improvement of any kind (except portable outhouses and dumpsters with lids or covers during construction) shall be placed upon any portion of the Property either temporarily or permanently.
- 10.9 Drilling. Except as permitted for earth-coupled heat pumps or similar devices as provided for below, no oil drilling, oil gas or mineral development operations, oil refining, geothermal exploration or development, quarrying or mining operations of any kind shall be permitted on the Property, nor shall oil wells, tanks, tunnels or mineral excavations or shafts be permitted on or below the surface of any Lot. Further, except as permitted for earth-coupled hear pumps or similar devices as provided for below, no derrick or other structure used in boring for water, oil, geothermal hear or natural gas shall be erected maintained or permitted on the Property.

The Board in its discretion may approve earth-coupled heat pumps or similar devices which may require the excavation or drilling of vertical or horizontal trenches or shafts below the surface of the improved area of a Lot.

- 10.10 Open Space Surrounding the Property. Lands surrounding the Property may be owned by the State or Federal Government and must not be dumped upon, disturbed or used for storage of any kind. Such lands may not be used for purposes other than those permitted by the agencies or governments having control of such lands.
- 10.11 Types of Homes Prohibited. Split entry (bi-level) homes will not be permitted in this Property unless approved by the ACC. No RVs, modular homes, underground or basement homes, round homes, octagon homes, prefabricated homes, rebuilt homes, concrete homes, or any other unusual style of home shall be allowed in the Property regardless of ACC approval of the same. No solar homes can be built unless approved by the ACC.
- 10.12 Exteriors of Homes. Exterior material may be used only upon the express approval of the ACC. All roofs must be built using a tile or slate roof. Stucco should be of a slightly darker earth tone color, no pastels or white are to be used.
 - 10.13 Setbacks. All setbacks shall comply with City of Hurricane ordinances.
- Landscaping. All front yard landscaping, as well as side yard landscaping reaching to the balf-way point of the total depth of the home, including grass (if any), trees and shrubs must be completed at the issuance of a Certificate of Occupancy by the City of Hurricane. All landscaping shall be compatible with other homes in the Property. Shrub and tree planting and landscaping on corner lots shall be located so as not to obstruct the view and create a hazard for the movement of vehicles or pedestrians along the street.
- 10.15 <u>City of Hurricane Requirements</u>. All structures built on any Lot must be constructed in accordance with all applicable zoning and building ordinances of the City of Hurricane.

- 10.16 Driveways Driveways shall be constructed out of concrete, inlaid brick, or other hard materials approved by the ACC. Driveways shall be limited solely to providing a connection between the street and the garage area; no private lanes or streets traversing Lots shall be allowed. All vehicles must be parked in the garage, not in the driveway or street.
- 10.17 Walls. No separation wall, not including the retaining wall, shall exceed seven (7) feet in height. Only masonry walls will be permitted on the exterior of the Lot (sides and rear). All walls must be substantially the same as walls built as a part of the original construction of the development.
- 10.18 Further Subdivision; Lease Provisions. No Owner shall further partition or subdivide his Lot or the rooms in the Dwelling Unit, including without limitation any division of his Lot into time-share estates, time-share uses, or creation of additional living quarters; provided, however, that this provision shall not be construed to limit the right of an Owner (1) to rent or lease his entire Lot to a single family by means of a written lease or rental agreement subject to the restrictions of this Declaration, so long as the Lot is not leased for transient or hotel purposes; (2) to sell his Lot; or (3). to transfer or sell any Lot to more than one person to be held by them as tenants-in-common, joint tenants, tenants by the entirety or some other form of joint ownership. The terms of any such lease or rental agreement shall be made expressly subject to this Declaration and the Bylaws of the Association. Any failure by the lessee of such Lot to comply with the terms of this Declaration, the Bylaws of the Association or the Rules and Regulations shall constitute a default under the lease or rental agreement.
- 10.19 <u>Drainage</u>. There shall be inclinterference with or alteration of the established drainage pattern over any Lot on the Property junless an adequate alternative provision is made for proper grainage. For the purposes hereof "established drainage pattern" is defined as the drainage which exists at the time that such Lotis conveyed to a purchaser from Declarant, and shall include drainage from the Lots on the Property onto the Common Area.
- 10.20 Water Supply and Sewage Disposal Systems. No individual water supply or sewage disposal system shall be permitted on any Lot on the Property unless such system is designed, located, constructed and equipped in accordance with the requirements, standards and recommendations, if any, of the ACC and of any public agency having jurisdiction over the Property, the Washington County, Utah, Health Department, and all other applicable governmental authorities.
- 10.21 Trash Receptacles. Owners shall keep trash receptacles in the garage or on the pation screened, and out of eyesight of the neighbors, except when placing the receptacles at the curb for pick up. The Board may pass additional Rules and Regulations governing trash receptacles.
- 10.22 Exception for Declarant. Notwithstanding the restrictions contained in this Article X, Declarant shall have the right to use any Lot or Dwelling Unit owned or leased by it in furtherance of any reasonably necessary or appropriate construction, marketing, sales, management, promotional,

or other activities designed to accomplish or facilitate the sale of Lots and/or Dwelling Units owned by Declarant. FCC Policy.

- Types of Antennas. This Section applies only to antennas, masts and dishes (a) collectively antennas) listed in FCC Rules. All other antennas, except the ones listed above are prohibited without the approval of the ACC.
 - (b) Location and Installation. In the antenna is one of the types now allowed under FCC Rules, the antenna must still comply with the following regulations:
 - No antenna may encroach upon the Common Area or the property of (i) another Owner.
 - Amantenna must be placed on the backside of the roof (or in the attical (ii) or screened in the backyard so no part of the antenna or satellite dish may be seen from the street in front of the Dwelling Unit, provided an acceptable signal quality may be received from such location. Antenna must be screened from 600 N. (Double tracted lots.)
 - The antenna must be shielded from view from the street and (iii) neighboring Property to the maximum extent possible as long as an acceptable signal quality may be received. If necessary to shield the antenna from view, the Association may require that the antenna be shielded by reasonably priced landscaping that complies with the Association's landscape requirements.
 - Antennas, masts and any visible wiring must be painted to match the color of the structure to which they are installed, provided the painting does not interfere with acceptable quality signal and does not void the manufacturer's warranty.
 - The anterna must comply with all applicable city, county and state laws, regulations and codes. The Association must be provided with a copy of any applicable governmental permits and local codes
 - Installation must be pursuant to the manufacturer's instructions.
 - In order to protect against personal injury and property damage, an antenna may not be placed in a location where it may come into contact with a power line.

- In order to protect against personal injury and property damage, all antennas must be properly grounded and secured.
- In order to protect against personal injury, antennas may not block or obstruct any driver's view of an intersection or street.

(c) Maintenance.

- The Owner is responsible for all costs associated with the installation and maintenance of an antenna.
- (ii) The Owner is responsible for all damage caused by or connected with the antenna.
- The Owner must hold the Association harmless and indemnify the Association the event that someone is injured by the antenna.
- The Owner shall keep the antenna in good repair so that it does not violate any portion of this Section.
- (d) FCC Notice. The Foundation, maintenance, or use wit: FCC Notice. The FCC Rules provide that a restriction will impair
 - Causes unreasonable delay in installation;
 - Unreasonably increases the cost of the equipment or its installation,

(e) Notification.

- An Owner must complete the notification form attached as Exhibit C and submit a copy of the completed form to the Association within five (5) business days after installing an antenna allowed pursuant to this Section.
- If requested by the Association, the Owner must establish a mutually convenient time to meet with a representative of the Association to review and discuss the antenna.

Enforcement.

- In the event of a violation of this Section, the Association may bring an action for declaratory relief with the FCC or the Fifth District Court, Washington County, after notice and an apportunity to be heard. If the FCC or Court determines that this Section is enforceable, the Owner shall pay a \$50,00 fine to the Association for each violation. If the violation is not corrected within a reasonable length of time, additional fines of \$10.00 per day will be imposed for each day that the violation continues.
- If an antenna poses a serious, immediate safety hazard, the Association may seek injunctive relief to compel the removal of the antenna.
- (iii) The Association shall be entitled to recover its reasonable attorney's fees, costs and expenses incurred in the enforcement of this Section.

(g) Severabili

- (i) If any provision of this Section is ruled invalid, the remainder of this Section and the Declaration shall remain in full force and effect.
- If the FCC modifies its rules, the modified rules shall be incorporated (ii) into this Section as if fully set forth herein.

ARTICLE XI

DAMAGE AND CONDEMNATION

Damage to or destruction of all or any portion of the Common Area and condemnation of all or any portion of the Common Area shall be handled in the following manner:

- (a) Each Member shall be liable to the Association for any damage to the Common Area or Improvement thereon sustained by reason of the negligence or willful amusconduct of said Member. At expenses of fixing the damage may be levied by the Association as a Corrective Assessment.
- If at any time the Common Area, or any part thereof, shall be taken or condemned by any anthority having the power of eminent domain, the Association shall represent the Lot Owners in these proceedings, negotiations, settlements or agreements. All compensation and damages shall be payable to the Association and shall be used promptly by the Association to the extent necessary for restoring and replacing any Improvements on the remainder of the Common Area. Upon completion of such work and payment in full therefor, any proceeds of condemnation then or thereafter in the hands of the Association

which are proceeds for the taking of any portion of the Common Area shall be disposed of in such manner as the Association shall reasonably determine.

ARTICLE XII

INSURANCE

- Casualty Insurance. The Association may secure liability and casualty insurance for the Common Area.
- Fidelity Insurance. A fidelity policy or policies to protect against dishonest acts on 12.2 the part of Board, officers, Manager, employees of the Association and all others (including volunteers) who handle or are responsible for handling funds of the Association. This fidelity coverage shall name the Association as the obligee or insured and shall be written in an amount sufficient to offer the protection reasonably required, but in no event less than one hundred percent (109%) of the Association's estimated annual operating expenses including reserves. The fidelity bond or insurance shall contain waivers of any defense based upon the exclusion of persons who serve without compensation from any definition of "employee" or similar expression. Said policy shall also provide that it may not be canceled or substantially modified (including cancellation for non-payment of premiums without at least thirty (30) days prior written notice to all Mongagees of Lots.
- Lots and Dwelling Units Not Insured by Association. The Association shall have no 12.3 duty or responsibility to procure or maintain any fire, liability, extended coverage or other insurance covering any Lot or Dwelling Unit on a Lot or any Improvement thereon erected by the Owner.

ARTICLE XIII

MORTGAGEE PROTECTION CLAUSE

Notwithstanding any other provision of this Declaration, the following provisions concerning the rights of first Mortgagees shall be in effect:

- Preservation of Regulatory Structure and Insurance. Onless the holders of seventy-five percent (75%) of all first Mortgagees and seventy-five percent (75%) of the Lot Owners shall have given their prior written approval, the Association shall not be entitled by act or omission to change, waive or abandon any scheme of regulations, or enforcement thereof, pertaining to the Architectural design of the exterior, appearance of Dwelling Units, the exterior maintenance of Dwelling Units, or the upkeep of the Common Area;
- 13.2 Notice of Matters Affecting Security. The Association shall give written notice to any first Mortgagee of a Lot requesting such notice wherever:

- (b) there is any condemnation proceedings or proposed acquisition of a Dwelling Unit or of any portion of the Common Area within ten (10) days after the Association learns of the same the Association plans to abandon or terminate the planned unit development established by this Declaration.
- 13.3 <u>Notice of Meetings</u>. The Association shall give to any first Mortgage of a Lot requesting the same, notice of all meetings of the Association, and such first Mortgage shall have the right to designate in writing a representative to attend all such meetings.
- Right to Examine Association Records. Any first Mortgage shall have the right to examine the books, records and audit financial statements of the Association.
- Trust) on a Lot and any parchaser from it who comes into possession of the Lot by virtue of foreclosure of the mortgage, or by deed or assignment in the of foreclosure, or pursuant to a power of sale or otherwise will take the Lot free of, and shall not be liable for any claims for unpaid assessments and charges against the Lot which accrue prior to the time such holder comes into possession of the Lot.

ARTICLE XIV

GENERAL PROVISIONS

- 14.1 <u>Enforcement</u>. This Declaration may be enforced by the Association, Declarant, and any Owner as follows:
 - Regulations, Rules and Regulations, Bylaws, or Articles and the continuation of any such breach may be enjoined, abated or remedied by appropriate legal proceedings instituted by any Owner, including Declarant so long as Declarant owns a Lot in the Property, and by the Association. The offending party is entitled to such notice and rights to a hearing as provided for in the Bylaws. Any judgment rendered in any action or proceeding pursuant hereto shall include a sum for attorneys' fees in an amount as the court may deem reasonable, in favor of the prevailing party, as well as the amount of any delinquent payment, interest thereon, costs of collection and court costs. Further, if the Association is successful in the defense of any action under the Declaration, ACC Rules and Regulations, Rules and Regulations, Bylaws, or Articles initiated by an Owner, the Association shall be entitled to an award of its costs and reasonable attorney's fees.

 - Any breach or amendment of the provisions contained in this Declaration, the (e) Articles or the Bylaws shall not affect or impair the lien or charge of any first Mortgage made in good faith and for value on any Lot or the Improvements thereon, provided that any subsequent Owner of such property shall be bound by such provisions of the Declaration. Articles and Bylaws, whether such Owner's title was accounted by foreclosure in a trustee? sale or otherwise.
 - Severability. Invalidation of any provision of this Declaration by judgment or court 14.2 order shall in no way affect any other provisions which shall remain in full force and effect.
 - Term. Unless earlier terminated pursuant to Section 14.5 below, the covenants and restrictions of this Declaration shall run with and bind the Property, and shall inure to the benefit of and be enforceable by the Association, the Declarant for so long as Declarant owns a Lot in the Development, or the Owner of any land subject to this Declaration, their respective legal representatives, heirs, successive Owners and assigns, for a term of fifty (50) years from the date this Declaration is Recorded, after which the term shall be automatically extended for successive periods of ten (10) years unless a declaration of termination satisfying the requirements of an amendment to the Declaration as set forth in Section 14.5 is Recorded.
 - Interpretation. The provisions of this Declaration shall be liberally construed to effectuate its purpose of creating a uniform plan for the development of a residential community and for the maintenance of the Common Area. The article and section headings have been inserted for convenience only, and shall not be considered or referred to in resolving questions of interpretation of construction. Unless the context requires a contrary construction, the singular shall include the plural and the plural the singular; and the masculine, ferginal and neuter shall each include the masculine, feminine and neuter.
 - Amendment. Any amendment to this Declaration shall require the affirmation of at 14.5 least two-thirds (2/3) of all Class A Membership votes represented in person, by proxy, or by ballot are entitled to cast at a meeting duly called for such purpose and the written consent of the Declarant

Notwithstanding anything herein contained to the contrary, for so long as Declarant holds Class B votes, Declarant shall have, and it hereby vested with, the right to unilaterally amend this Declaration as may be reasonably necessary or desirable; (a) to more accurately express the intent of any provision of this Declaration in light of then existing circumstances, information or mortgage requirements, (b) to better insure, in light of then existing circumstances or information, workability of the arrangement which is contemplated by this Declaration; or (c) to conform this Declaration, or any amendments thereto, to local ordinances, we Utah law, or to the requirements of law of any other jurisdiction or state where the project may be registered, or as may be amended from time to time, or to conform to the underwriters guidelines of major secondary market investors in order to facilitate the availability of financing. Any amendment authorized pursuant to this Section shall be accomplished through the Recordation of an instrument executed by the Association. In such instrument an officer of the Association or member of the Board shall certify that the vote required by this Section for amendment has occurred, except for amendments unilaterally made by the Declarant.

- Notice. Any notice, including without limitation Notice of a violation of this Declaration, the Bylaws, or any Rules and Regulations of the Association, permitted or required to be delivered as provided herein shall be fair and reasonable if given in writing and may be delivered either personally or by first class or registered mail. If delivery is made by mail, it shall be deemed to have been delivered three (3) business days after a copy of the same has been deposited in the United States mail, postage prepaid, addressed to any person at the address given by such person to the Association for the purpose of service of such notice, or to the residence of such person if no address has been given to the Association. Such address may be changed from time to time by notice in writing to the Association. Notwithstanding the foregoing, notice given by other means shall be deemed fair and reasonable if given in accordance with the Utah Revised Nonprofit Corporation Act
- 14.7 Manager The Association may carry out through a Manager any of its functions which are properly the subject of delegation. Any Manager so engaged may be an independent contractor or an agent or employee of the Association. Such Manager shall be responsible for managing the Property for the benefit of the Association and the Owners, and shall, to the extent permitted by law and the terms of a management agreement with the Association, be authorized to performany of the functions or acts required or permitted to be performed by the Association itself.
- Terms of Management Agreement. Any agreement for professional management of the Development, or any other contract providing for services of the Declarant, sponsor, or builder may not exceed three (3) years.  - sets forth such additional limitations, restrictions, covenants, conditions (c) complementary additions to the covenants, conditions and restrictions contained in this Declaration as are not inconsistent with this Declaration and which do not create a character different than exists in the Development and is intended by this Declaration.
