**INGRESS-EGRESS EASEMENT  
(Parcel "E")**

**GRANT, TRANSFER and CONVEY to**

**Hurricane City, a municipal corporation of the State of Utah**, grantee(s), its successors and assigns, of Hurricane, County of Washington, State of Utah, for the sum of One DOLLAR (\$1.00) AND OTHER GOOD AND VALUABLE CONSIDERATION, a perpetual ingress and egress easement to replace and maintain, utilities and access over, across and through the following described tract of land in WASHINGTON County, State of UTAH:

Commencing at the South Quarter Corner of Section 31, Township 41 South, Range 13 West, Salt Lake Base and Meridian; thence North 00°06'34" West along the Center Section line 674.88 feet to a point on the Northerly right-of-way line of Highway SR-9; thence South 73°39'38" West, along said right-of-way line a distance of 790.67 feet to the Point of Beginning; thence South 73°39'38" West along said right-of-way line, a distance of 325.82 feet; thence North 19°16'48" West, a distance of 40.00 feet; thence North 72°54'13" East, a distance of 258.28 feet; thence North 45°18'42" East, a distance of 44.11 feet; thence North 25°38'18" East, a distance of 109.86 feet; thence South 00°01'13" East, a distance of 151.90 feet to the Point of Beginning.

The consideration hereinabove recited shall constitute payment in full for the above-mentioned easement. The Grantee covenants to maintain the easement in good repair so that no unreasonable damage, or problems will result from its use. The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the Grantee, its successors and assigns.

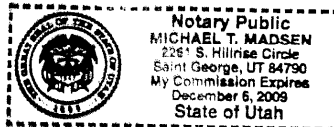
