Partial Assignment of Declarant Obligations and Duties
(All of Northbridge Sphilivisjon and All of Northbridge Estates)

Northbridge Development, L.L.C. is the Declarant of the Northbridge Project under that certain Declaration of Covenants, Conditions and Restrictions for Northbridge Estates and NORTHBRIDGE AND PROPERTY PROPERTY No. 928986, in Book 1716, beginning at page 2132, as amended and supplemented from time to time (the "Declaration").

The Northbridge Project consists of Northbridge Estates Phase 1 ("NBE-1"). Northbridge Estates Phase 2 ("NBE-2") and Northbridge Estates Phase 3 ("NBE-3") and Northbridge Subdivision Phase 1 ("NBS-1"). Northbridge Subdivision Phase 2 ("NBS-2"), and Northbridge Subdivision Phase 3 ("NBS-3"), and such additional real property as may be added to the project under the terms of the Declaration (collectively the "Northbridge Project"). Northbridge Development has recorded plat maps in the official records of the Washington County Recorder for NBS-1, NBS-2, NBE-1 and NBE-2. It is anticipated, but not required, that the real property comprising NBS-3 and NBE-3 will be annexed into the Northbridge Project and subjected to the Declaration.

Article 12, Section 12.4 of the Declaration gives Northbridge Development, L.L.C. the authority to delegate, transfer or assign its Declarant rights, powers, duties and obligations. Under such power and authority, Northbridge Development, L.L.C. hereby makes the following representations, assignments, transfers and delegations and retains and reserves to Northbridge Development, L.L.C. certain obligations, duties, responsibilities and liabilities:

1. <u>Assignment of All Declarant Rights and Powers</u>. Northbridge Development, L.L.C. hereby assigns to Split Rock, Inc. and Split Rock, Inc. hereby assumes all of Northbridge Development's rights and powers as Declarant for the entire Northbridge Project (NBS-1, NBS-2, NBS-3, NBE-1, NBE-2, NBE-3, and all future additions).

- 2. <u>Responsibility for Pre-existing Improvements</u>. Northbridge Development, L.L.C. has completed, or will complete, and will remain responsible and liable for all the improvements to the public and private streets, easements, water, utilities, sewer, curbs and gutters, sidewalks, and other related subdivision infrastructure for NBS-1, NBE-1, and lots 32 through 38 of NBS-2. (Collectively the "NB Improvement Obligations").
- 2. Retention and Non-Assignment of Certain Duties, Etc (NBS-1, NBS-2, NBE-1). Northbridge Development, L.L.C. specifically does not assign to Split Rock, Inc. and Split Rock, Inc. does not accept or assume (i) any of Northbridge Development, L.L.C.'s Declarant duties, obligations, responsibilities and liabilities related to NBS-1, NBE-1 or lots 32 through 38 of NBS-2 or (ii) any of the NB Improvement Obligations.
- 3. Assignment of All Other Duties. Northbridge Development, L.L.C. hereby assigns and Split Rock, Inc. hereby assumes all of Northbridge Development, L.L.C.'s Declarant obligations and duties for NBE-2, NBE-3, lots 39 through 80 of NBS-2, NBS-3 and all future additions to the Northbridge Project, subject to such warranty for existing subdivision improvements as Northbridge Development, L.L.C. has given by separate agreement to Split Rock, Inc.
