This Court having considered its Order Awarding Attorney Fees and Costs, as well as the prior Order and Judgment entered in this matter, and good cause appearing therefore, the Court now makes and enters the following Amended Judgment,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that:

1. Plaintiffs are hereby granted Judgment, against Defendants Edward Jason Neal and Stacy L. Neal, in the principal amount of \$19,186.18.

2. Plaintiffs are awarded pre-judgment interest of Five Percent (5%) per month in the amount of \$820.01 through March 17, 2008.

3. Plaintiffs are further awarded post-judgment interest from the date even herewith at the contractual rate of 5% per month, compounding monthly.

4. Plaintiff is awarded all costs and attorney's fees incurred in bringing this matter to judgment in the amount of \$3,505.31.

5. Plaintiff is awarded a total judgment against Defendants in the amount of \$23,511.50, plus interest at a rate of five percent (5%) per month.

IT IS FURTHER ORDERED that this Judgment shall be augmented in the amount of reasonable costs and attorney's fees expending in collecting said Judgment by execution or otherwise as shall be established by affidavit.
