**AMENDMENT TO THE DECLARATION OF  
COVENANTS, CONDITIONS AND RESTRICTIONS  
OF  
PARADISE CANYON  
(Leases)**

This Amendment to the Declaration of Covenants, Conditions, and Restrictions of Paradise Canyon (Leases) (this "Amendment"), amends the following: (i) Declaration of Covenants, Conditions, and Restrictions of Paradise Canyon, dated April 6, 2000; recorded April 27, 2000, as Entry No. 00683469, in Book 1367, beginning at Page 0295 (the "Declaration"), (ii) the Declaration of Annexation [Phase 2], recorded January 17, 2001 as Entry No. 707578 in Book 1391 beginning at page 2680, (iii) the Declaration of Annexation [Phase 3], recorded February 7, 2001 as Entry No. 709782 in Book 1394 beginning at page 1477, (iv) the Declaration of Expansion [Phase 4], recorded July 11, 2002 as Entry No. 00772595 in Book 1474 beginning at page 2482, (v) the Declaration of Expansion [Phase 5], recorded March 4, 2003 as Entry No. 00807086 in Book 1527 beginning at page 0725, (vi) Amendment to Declaration of Covenants, Conditions, and Restrictions of Paradise Canyon, dated September 13, 2001; recorded September 14, 2001, as Entry No. 00, in Book 1426, beginning at Page 1666, and (vii) any and all supplements or amendments to the Declaration prior to the date of this Amendment, whether or not such were recorded in the records of the Washington County Recorder. Specifically, this Amendment adds to Article 8, Section 8.15 of the Declaration. In the event of a conflict between the Declaration, the Bylaws or the Rules and Regulations for Paradise Canyon, this Amendment shall control.

This Amendment shall be binding against all of the property described in the Declaration and any annexation, expansion or supplement thereto. Namely, all five phases of Paradise Canyon more particularly described in the attached Exhibit "A."

This Amendment is undertaken pursuant to Article 11, Section 11.4 of the Declaration, and was approved in writing by at least sixty-seven percent (67%) of all Owners.

This Amendment shall take effect upon the date it is recorded in the records of the Washington County Recorder (the "Amendment Date").

Amendment

Article 8, Section 8.15 currently reads:

Section 8.15 Leases. Any lease or rental agreement shall be in writing and shall provide that the terms of the lease shall be subject in all respects to the provisions of this Declaration, the Articles of Incorporation, Bylaws and Rules and Regulations of the Association and that any failure by lessee to comply with the terms of such documents shall be a default under the lease.

Article 8, Section 8.15 is hereby amended to add the paragraphs as follows:

No Townhome shall be leased for transient purposes. A lease for a period of less than six (6) months shall be deemed to be for transient purposes. No Owner shall lease less than his entire Townhome. Copies of all leases shall be provided to the Board for its records.

No Owner may designate a tenant as family, friends or invited guests in order to avoid the intent of this provision.

Article 8, Section 8.15 now reads in its entirety:


Section 8.15 Leases. 




