THIRD AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR NORTHBRIDGE ESTATES AND SUBDIVISION

(Annexation of Phase 3)

This Third Amendment to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Northbridge Estates and Subdivision ("Third Amendment") is executed pursuant to the provisions of the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Northbridge Estates and Subdivision as described in Recital A hereof, by Plumb Holdings, L.L.C., a Utah limited liability company ("Declarant").

RECITALS

- A. On October 9, 2009, Declarant's predecessor-in-interest, Split Rock, Inc., a Utah corporation, recorded in the Official Records of Washington County, State of Utah, that certain Amended and Restated Declaration of Covenants, Conditions and Restrictions for Northbridge Estates and Subdivision as Document No. 20090038974, as amended (the "Declaration"), covering the real property known as Northbridge Estates and Northbridge Subdivision (the "Project") located in Washington County, Utah, as more particularly described in Exhibit "A" attached hereto and incorporated herein by this reference (the "Property").
- B. Pursuant to Section 11.2 of the Declaration, Declarant reserved the right to unilaterally amend the Declaration, without prior approval of the Association or its Members, for the purpose of subjecting additional land to the Declaration. Accordingly, Declarant now desires to exercise its unilateral right to amend the Declaration for the purpose set forth and described in this Third Amendment by subjecting the additional land described on Exhibit "B" attached hereto and incorporated herein by this reference (the "Additional Land") to the Declaration.
- C. In connection with Declarant's exercise of its expansion rights described above, twenty-three (23) Lots will be added to the Project, as identified in the subdivision plat to be recorded of even date herewith entitled "Northbridge Estates Phase 3" (the "Phase 3 Plat").

NOW, THEREFORE, Declarant hereby unilaterally amends the Declaration as follows:

1. <u>Defined Terms and Status of Recitals</u>. Capitalized terms used and not otherwise defined in this Third Amendment shall have the meaning or meanings given to them in the Declaration. The Recitals set forth above shall constitute a portion of the terms of this Third Amendment.

- 2. <u>Annexation of Additional Land</u>. Declarant hereby exercises its rights under Section 11.2 of the Declaration to subject the Additional Land to the Declaration. Accordingly, the real property described in Exhibit "B" attached hereto is hereby added to and made a part of the Project, as more particularly set forth in the Phase 3 Plat. Declarant declares that from and after the recordation of this Third Amendment and the Phase 3 Plat, the Additional Land shall be held, transferred, sold, conveyed, and occupied subject to the covenants, conditions, restrictions, easements, charges and liens set forth in this Declaration, as the same may be amended and supplemented in accordance with Section 11.1 of the Declaration.
 - 3. <u>Voting Rights</u>. Owners of Lots within the Phase 3 Plat shall be Class B Members.
- 4. <u>Plumb Lots</u>. To the extent the Lots within the Phase 3 Plat are "Plumb Lots," as such term is defined in that certain Second Amendment to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Northbridge Estates and Subdivision recorded February 1, 2012, as Entry No. 20120003404, Official Washington County Records (the "Second Amendment"), the terms of the Second Amendment shall control with respect to Minimum Area, Unit Height, Setbacks, exteriors, number of stories and other development restrictions set forth in the Second Amendment. If not directly addressed in the Second Amendment, the terms of the Declaration shall control with respect to the development of the Lots within the Phase 3 Plat.
- 5. <u>Declaration Remains in Effect</u>. This Third Amendment shall be considered supplemental to the Declaration. Except as expressly amended by the foregoing, the Declaration shall remain in full force and effect and shall not be canceled, suspended or otherwise abrogated or amended by the recording of this Third Amendment.
- 6. <u>Authority</u>. Declarant hereby certifies that the Declarant may execute this Third Amendment without the signature of any other party as provided in Section 11.2 of the Declaration, as amended by this Third Amendment.
