

Dear Mr. Wheeler:

The purpose of this notice is to make you aware that you are not in compliance with the City Business License ordinance which regulates rental dwellings. Our records show that you have not obtained a rental dwelling business license for the license period of July 1, 2013 thru June 30, 2014. The rental dwelling business license is required to operate and maintain your rental dwelling unit located at 1762 West 70 South Circle St. George, Utah. This Notice informs you of your rights and the consequences if you fail to comply with the Rental Fit Premises ordinance. Please read it carefully.

VIOLATION(S)

- 1. You are in violation of failing to obtain a Rental Dwelling Business License Chapter 7 section 4-7-3.
- 2. You are in violation of failing to designate a Washington County person authorized to act on your behalf for the purpose of the Rental Dwelling Business License. Chapter 7 section 4-7-7.

REMEDIAL ACTION

In order to bring your business into compliance with the City Rental Dwelling Ordinance you must obtain a Rental Dwelling Business License by November 8, 2013.

FAILURE TO COMPLY

Failure to comply will result in the assessment of fines in the amount of \$50.00 per day per violation, plus administrative costs, beginning on November 8, 2013. The fines and costs will continue to accrue until you come into compliance. In addition to the assessment of fines and administrative costs, if you fail to correct the violation by the indicated deadline, the city may pursue other legal remedies, which include, but are not limited to: injunctions and criminal prosecution.

DEFENSES

If you no longer own the rental dwelling unit that requires a Rental Dwelling Business License, please provide the city with a copy of the documents showing the transfer of ownership so that no charges are assessed to you. You may e-mail me the information to sgcitybuslic@sgcity.org.

HEARING RIGHTS

You have the right to request a hearing to determine if any violations exist on your property or if you have allowed violations to occur for which you are responsible. You must file a **written** request for hearing within ten (10) days from the date the notice of violation was issued. If the notice was mailed, the request for hearing must be made within fifteen (15) days of the mailing date. Please include your name, address, and telephone number. An administrative Fee may be assessed for costs associated with the hearing of your case. You have the right to hire an attorney to represent you in the hearing, although it is not required. An attorney will not be appointed for you. If you hire an attorney, you must notify this office at least ten (10) days before the hearing. A notice of hearing will be mailed to you instructing you when and where to appear.

FAILURE TO FILE A TIMELY WRITTEN REQUEST FOR A HEARING WAIVES YOUR RIGHT TO A HEARING.

Please take note no additional notice will be sent. It is <u>YOUR RESPONSIBILITY</u> to remedy the violation and contact our office before the indicated deadline. If you fail to comply with this notice the City Attorney may institute a civil suit to enjoin the operation of any business being operated without a license and/or may seek criminal sanctions.
