TEMPORARY POWER EASEMENT

For the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned Grantor hereby grants, conveys, sells, and sets over unto Westerly Properties, LLC, a Delaware limited liability company and Paul Walker Hardman, Trustee of the Family Trust portion of the W&E Hardman Trust dated January 28, 1992, as Grantee, its successors and/or assigns, a temporary easement for electric power transmission lines and all necessary accessories and appurtenances thereto around, upon, over, across and through a parcel of land situated in Utah County, State of Utah, described as follows:

Beginning at a point being North 89°57'58" East 1,321.64 feet along the section line and North 00°09'03" East 16.55 feet from the South Quarter Corner of Section 35, Township 4 South, Range 1 West, Salt Lake Base and Meridian; and running thence South 89°58'01" West 10.00 feet; thence North 00°09'03" East 1,312.38 feet; thence North 89°53'41" East 10.00 feet; thence South 00°09'03" West 1,312.39 feet to the point of beginning.

To have and hold the same unto said Grantee, its successors and assigns, with right of ingress and egress in said Grantee, its contractors and assigns to enter upon the above described property with such equipment as is necessary to install, maintain, operate, repair, inspect, protect, remove and replace said easement.

It is understood and agreed that this easement will automatically terminate without further action of Grantor or Grantee when permanent power is established.
