DECLARATION OF ANNEXATION FOR PHASE 4 OF THE VISTAS AT ENTRADA AT SNOW CANYON

Lots 27-33

Ben Shakespeare ("Owner"), by virtue of that certain Trustee's Deed recorded April 15, 2016, as Doc. The undersigned hereby consent to the annexation of Phase 4, Lots 27-33 into The Vistas at Entrada at Snow Canyon and further declare that the Phase 4, Lots 27-33 Property shall hereafter be held, sold, conveyed, encumbered, leased, used, occupied and improved as part of the Properties (as that term is used in the Declaration) and subject to the Declaration and all protective covenants, conditions, restrictions and equitable servitudes set forth in the Declaration, as amended from time to time, the terms of which are deemed incorporated herein by this reference, and to the jurisdiction of the Association and entitled to all rights and privileges afforded therein. The covenants, conditions and restrictions of the Declaration are intended to, and shall in all cases run with the title of the land, and be binding upon the successors, assigns, heirs, lien holders, and any other person holding any interest in the Phase 4, Lots 27-33, and shall inure to the benefit of all other lots that are subject to the Declaration. The covenants, conditions and restrictions of the Declaration shall be binding upon the undersigned including, Entrada at Snow Canyon Property Owners Association, Inc. and the Owner as well as their successors in interest, and may be enforced by them or by an owner to the extent provided in the Declaration.

The Owner and the Entrada at Snow Canyon Property Owners Association, Inc. hereby consent and agree to this Declaration of Annexation and the annexation of the Phase 4, Lots 27-33 Property into The Vistas at Entrada at Snow Canyon and to the Phase 4, Lots 27-33 Property being subject to the Declaration and all amendments and supplements thereto.


