Subject to any valid, existing rights of way of any kind and any right, interest, reservation or exception appearing of record, including but not limited to reservations and exceptions in prior conveyances from the United States, subject to Easement No. 876 issued to Dixie-Escalante Rural Electric Association, Inc., Easement No. 3249, as amended, issued to Francis B. Munoz, and Easement No. 1542 issued to the City of St. George, and subject also to all rights of way for ditches, tunnels, and telephone and transmission lines that have been or may be constructed by the United States as provided by statute.
