On January 3, 2020, a one-day bench trial in this case was held at the Third District Court, West Jordan District, Salt Lake County, State of Utah, with the Honorable Judge James Gardner presiding. Plaintiffs Gordon E. Harmston, Jr. and Katherine Louise Mason Harmston, as Trustees of the Gordon E. Harmston Jr. Trust ("Plaintiffs" or the "Trust" appeared personally and were represented at trial by their attorney John L. Cooper of Parsons Behle & Latimer.

Defendants Jay R. Rice and Rice Asset Management, LLC don AR Real Estate Development ("JAR"), (collectively "Defendants") were represented at trial by their attorney Aaron M. Reed of the Law Office of Aaron M. Reed. Mr. Rice appeared personally and as a representative of JAR.

The Court having fully considered the evidence presented at trial and the arguments of the parties, ruled in favor of Plaintiffs. On February 6, 2020, the Court entered its Findings of Fact and Conclusions of Law. The Court found that the Trust was entitled to damages in the amount of \$50,000.00 pre and post judgment interest, and, as the prevailing party, to an award of attorney fees.

Based on the Court's Findings of Fact and Conclusions of Law, the Trust was awarded \$50,000 in damages before prejudgment interest. With prejudgment interest accruing from January 26, 2018, to March 11, 2020, the total amount of prejudgment interest, calculated at a rate of 10% per annum pursuant to Utah Code Ann. 15-1-1(2), is \$10,614.75.

On March 10, 2020, the Court entered its Findings of Fact, Conclusions of Law, and Order on Attorneys' Fees and Costs ("Findings and Conclusions on Attorney Fees"). In the Court's Findings and Conclusions on Attorney Fees, the Court concluded that the Trust is entitled to attorney fees in the amount of \$54,940.50 and costs in the amount of \$3,273.22, for total fees and costs of \$58,213.72. The Court also concluded that pursuant to its December 13, 2019 Order, Defendant Jay Rice remains jointly liable with JAR for \$1,955.30 of the \$58,213.72.

Consistent with the Court's (1) Findings and Conclusions of Law and (2) Findings and Conclusions on Attorney Fees, and for good cause appearing, the Court hereby ORDERS that:

Judgment is entered in favor of Gordon E. Harmston, Jr. and Katherine Louise

Mason Harmston, as Trustees of the Gordon E. Harmston Jr. Trust, in the amount of \$118,828.47, which includes \$50,000.00 in damages, \$10,614.75 in prejudgment interest, and \$58,213.72 in attorney fees and costs against Rice Asset Management, LLC dba JAR Real Estate Development.

- 2) Defendant Jay R. Rice is jointly liable with Defendant JAR for \$1,955.30 of the total amount of attorney fees and costs of \$58,213.72 included in this Judgment.
- 3. Post judgment interest shall be calculated at the above rate from the date of this Judgment through the date of full collection of this Judgment.
- 4. All claims and liabilities as to all parties having now been adjudicated. This Judgment constitutes the Final Judgment of this Court in this matter.
