EXCLUSIVE POSSESSION ADDENDUM NO. 11 TO DEVELOPMENT LEASE AGREEMENT NO. 1100

This EXCLUSIVE POSSESSION ADDENDUM NO. 11 TO DEVELOPMENT LEASE AGREEMENT NO. 1100 (the "Addendum"), is effective March 2, 2020 (the "Effective Date"), by and between the State of Utah, through the School and Institutional Trust Lands Administration (the "Lessor"), and Desert Color St. George, LLC (the "Lessee").

Effective September 11, 2017, the parties entered into Development Lease Agreement No. 1100 (the "Lease"), under which certain lands in Washington County, Utah (the "Premises") were leased to Lessee to be subdivided and developed for residential and other related purposes.

Pursuant to section 2.4 of the Lease, Lessor has the right to enter, occupy, use and control the Premises until such time as exclusive possession and use is provided pursuant to the terms of the Lease.

1. The parties hereby acknowledge that one or more of the conditions described in the Lease has been met and that Lessee has exclusive possession and use of a certain portion of the Premises (the "Exclusive Possession and Use Parcel").
