FIRST AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS, EASEMENTS, TERMS AND RESERVATIONS FOR DESERT COLOR COMMUNITY

This First Amendment to the Amended and Restated Declaration of Covenants, Conditions, Restrictions, Easements, Terms and Reservations for Desert Color Community (the "First Amendment") is executed and adopted by Desert Color St. George, LLC (the "Declarant").

RECITALS

- A. The Amended and Restated Declaration of Covenants, Conditions, Restrictions, Easements, Terms and Reservations for Desert Color Community was recorded on July 29, 2020 as Entry No. 20200039512 in the office of the Washington County Recorder (hereinafter the "**Declaration**").
- B. This First Amendment affects the real property located in Washington County, State of Utah, described with particularity on Exhibit A, which exhibit is attached hereto and incorporated herein by reference.
- C. The Declarant desires to amend the Declaration as set forth in this First Amendment to clarify Impact Fee definitions and the terms and circumstances where the Master Association may assess Impact Fees.
- D. Unless otherwise set forth herein, the capitalized terms shall have their same meanings and definitions as stated in the Declaration.
- E. Pursuant to Article XX, Section 20.1 of the Declaration, the Declarant has elected to amend the Declaration pursuant to its unilateral amendment right.
- F. As of the date of the recording of this First Amendment, Declarant owns one or more Parcels in the Community and the Declarant Control Period remains in effect.

AMENDMENT

- **NOW, THEREFORE**, in consideration of the foregoing Recitals, the Declarant hereby executes this First Amendment, which shall be effective as of its recording date with the Washington County Recorder's office.
- (1) <u>Amendment No. 1</u>. Article VI, Section 6.16 of the Declaration shall be deleted in its entirety and shall be replaced by the following:

6.16 Impact Fees

The Board shall have the right, but not the obligation, within its sole discretion, to impose a schedule of Impact Fees for the costs of infrastructure and improvements provided to a Lot, Parcel or Unit. The Master Association may set Impact Fees by Board Resolution, Rule, or other similar Master

Association document. To the extent reasonably practical, Impact Fees shall be uniform for similarly situated Lots, Parcels, or Units and the benefits they receive; however, there shall be no requirement for uniform Impact Fees across the Community. The authority to assess Impact Fees shall be construed broadly to permit the Master Association to recover and pay for any and all costs incurred in the development and construction of improvements in the Desert Color Community. Impact Fees may be assessed at any time the Master Association determines, including, but not limited to: a transfer of title, an application for a building permit, or an application for connection to a utility facility. Impact Fees are intended to offset the effect that the development and occupancy of each Lot, Parcel or Unit will have on the infrastructure and environment within Desert Color Community. If the Association collects monies in excess of the amounts required to cover the costs of the infrastructure or facilities that are the purpose of the Impact Fees, then the Association may reimburse Owners the excess funds, or may hold such funds for the future benefit of the Lots served by the Impact Fee in the same proportional allocation in which the Impact Fees were assessed. Impact Fees shall be subject to all lien rights of the Master Association and shall be treated as Specific Assessments for collection purposes.

- (2) <u>Conflicts</u>. All remaining provisions of the Declaration and any prior amendments not specifically amended in this First Amendment shall remain in full force and effect. In the case of any conflict between the provisions of this document and the provisions of the Declaration or any prior amendments, the provisions of this document shall in all respects govern and control.
- (3) <u>Incorporation & Supplementation of Declaration</u>. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, definitions, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
