Should the Real Property be located in an area designated by the Administrator of the Federal Emergency Management Agency as a special flood hazard area, Trustor agrees to obtain and maintain flood insurance, if available, within 45 days after notice is given by Lender that the Property is located in a special flood magard area, for the full unpaid principal because of the loan and any prior liens on the property securing the loan up to the maximum policy limits set under the National Flood Insurance Program on as otherwise required by Lender, and to maintain such insurance for the term of the loan.
