LESSOR CONSENT AGREEMENT

This Lessor Consent Agreement (this "Agreement"); made and executed as of July and between ALTABANK, a Utah corporation ("Lender"); THE STATE OF UTAH, acting through the School and Institutional Trust Lands Administration ("Lessor"); and DESERT COLOR ST. GEORGE, LLC, a Utah limited liability company ("Lessee").

RECITALS

- A. Lessor and Lessee have entered into a Development Lease Number 1100 dated September 11, 2017 (together with any and all amendments, modifications and extensions, the "Lease"), whereby Lessor leases to Lessee and Lessee leases from Lessor, the real property located in Washington County, State of Utah and more particularly described on Exhibit. A" attached hereto and incorporated herein by this reference (hereinafter referred to as the "Leased Premises"), which leased real property is referred to commonly at Desert Color Resort Phase 5" and "Sage Haven".
- B. Lender has or will make a loan (the "Loan") to Lessee pursuant to the terms and conditions of a Loan Agreement, dated July 12, 2021, as amended (the "Loan Agreement"), which is secured by, among other collateral, a Deed of Trust, Assignment of Leases and Rents, Security Agreement and Financing Statement, dated July 12, 2021, and recorded on July 27, 2021, as entry No. 2020 50 206 in the official records of Washington County Recorder, State of Utah (the "Leasehold Trust Deed"), which ensumbers the leasehold interest of Lessee in the Leased Premises under the Lease (the Loan Agreement and the Leasehold Trust Deed, together with other loan documents evidencing and/or governing the Loan, are referred to collectively as the "Loan Documents").

<u>AGREEMENT</u>

In exchange for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, Lender, Lessor, and Lessee agree as follows:

- Lessor's Consent and Acknowledgment. Lessor hereby consents to, and acknowledges the enforceability of, the granting of the Leasehold Trust Deed in favor of Lender. The Leasehold Trust Deed shall not encumber fee title to the Deased Premises while such fee title is owned by Lessor, and, except as expressly set forth in this Agreement, shall be subject to all of the terms and conditions of the Dease and Lessor's rights thereunder
- 2. <u>Lessee Acknowledgments</u>. Lessee hereby certifies to and agrees with Lender that as of the date of this Agreement.
- a. The Lease is in full force and effect and is enforceable in accordance with its terms.

- b. Neither Lessee nor, to Lessee's actual knowledge, Lessor is in default under the Lease, and no event has occurred and no condition exists, which with the giving of notice, the passage of time, or both, would constitute a default by Lessee or Lessor under the Lease.
- c. There are no defenses, counterclaims or setoffs against rents or charges due or which may become due under the Lease, and no claim of any nature exists by Lessee or Lessor against the other under the Lease.
- d. The Lease shall not after the date of this Agreement be terminated and the rent provisions and the option to purchase provisions with respect to the Leased Premises shall not be amended without the prior written consent of Lender. Any attempted termination or amendment without the prior written consent of Lender shall be void.
- e. Lessee has not assigned, mortgaged, encumbered or otherwise transferred any or all of its interests under the Lease and, during the term of the Loan, agrees not to assign, mortgage, encumber or otherwise transfer any or all of its interests under the Lease without the prior written consent of Lender.
- 3. <u>Lessor's Acknowledgment</u>. Pursuant to Section 23.4 of the Lease, Lessor hereby certifies to and agrees with Lender that, as of the date of this Agreement, Lender is authorized to rely on all of the following certifications and agreements of Lessor as consideration for Lender making the Loan.
 - a. All "Annual Rent" under the Lease has been paid current.
 - b. There are not any uncured events of default under the Lease.
- c. The rent provisions and the option to purchase provisions under the Lease with respect to the Leased Premises shall not be amended after the date of this Agreement without the prior written consent of Lender.
- 4. <u>Lender's Rights.</u> Lessor acknowledges that the Leasehold Trust Deed constitutes a "Leasehold Mortgage" as described in Article 23 of the Lease, and that Lender shall have all rights, remedies and cure rights of a "holder of a Leasehold Mortgage" as described in the Lease, including without limitation Article 23 of the Lease.
- 5. <u>Notices</u>. All notices shall be in writing and shall be deemed to have been sufficiently given or served when personally delivered, deposited in the United States mail, by registered or certified mail, or deposited with a reputable overnight mail carrier which provides deliver of such mail to be traced, addressed as follows:
