

## ASSIGNMENT OF DECLARANT RIGHTS

This Assignment of Declarant Rights is entered into by and between, Rocky Canyon Properties, LLC, a Utah limited liability company ("Rocky Canyon"), and Padre Mountain Properties, LLC ("Padre Mountain"), (collectively the "Parties") and is effective as of the date it is recorded in the Washington County Recorder's Office (the "Effective Date").

#### RECITALS

- A. Under the Declaration of Covenants, Conditions, Easements and Protective Covenants of Palisades at Snow Canyon dated September 5, 2013, and recorded on November 19, 2013 with the Washington County Recorder as Document No. 20130043086 (the "Declaration"), Gardner Plumb Ivins, L.C. as Declarant under the Declaration established a planned unit development for single family homes to be known as "Palisades at Snow Canyon".
- B. The Declaration was subsequently amended on January 21, 2014, September 22, 2014, April 17, 2015, March 12, 2020, March 19, 2021, and April 8, 2021 (collectively the Amendments").
- C. Pursuant to Article 18 of the Declaration, and the Amendments, Gardner Plumb Ivins, L.C. assigned its rights as Declarant to Rocky Canyon on February 21, 2019. The assignment from Gardner Plum Ivins, L.C. to Rocky Canyon was recorded with the Washington County Recorder as Document No. 20190007298 on February 27, 2019.
- D. On September 2, 2022, Rocky Canyon, as Declarant, executed and recorded an Amended and Restated Declaration as Document No. 20220041697 with the Washington County Recorder (the "Amended and Restated Declaration") that relates to the property known as the Palisades at Snow Canyon which includes the real property identified as Exhibit "A" to this Assignment of Declarant Rights.
- E. Pursuant to Article 17 of the Amended and Restated Declaration, Rocky Canyon, as Declarant, now desires to assign all of its rights, title, interests, claims, and benefits as Declarant related to the planned development known as the Palisades at Snow Canyon to Padre Mountain from and after the Effective Date.

### ASSIGNMENT

NOW THEREFORE, in consideration of the premises, the mutual covenants and agreements herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

- 3. <u>Declaration of Authority.</u> As of the Effective Date, Rocky Canyon represents and warrants to Padre Mountain that it is the current Declarant under the Amended and Restated Declaration, and represents that it has the legal right and power to assign all of the Declarant rights under the Declaration, the Amendments, and the Amended and Restated Declaration, and that it does hereby assign and convey all Declarant rights under the Declaration, the Amendments, and the Amended and Restated Declaration to Padre Mountain and that it will indemnify and hold Padre Mountain harmless from any and all actions or liabilities in its role as Declarant prior to the Effective Date.
- 4. <u>Assumption.</u> Padre Mountain hereby accepts from Rocky Canyon the Assignment, and assumes all obligations relating thereto.


