PUBLIC EASEMENT

That in consideration of Ten Dollars and other good and valuable consideration paid to JACK ON THE RIVER LLC, a Utah limited liability company, herein referred to as Grantor, by the City of St. George, a Utah municipal corporation, herein referred to as Grantee, the receipt of which is hereby acknowledged, the Grantor does hereby grant, bargain, sell, transfer and convey unto Grantee, its successors and assigns, a non-exclusive perpetual easement for ingress and egress, to use, install, operate, maintain, repair, remove, relocate and replace trail facilities and for any other public use, in and along real property owned by Grantor in Washington County, State of Utah, and the easement being more fully described as follows:

TO HAVE AND TO HOLD such property to Grantee, the City of St. George, forever for the uses and purposes normally associated with public uses such as utilities and drainage.

Grantor, its successors and assigns, may not install, build, place or cause or allow anything to be installed, built, or placed in the easement. Grantor may not interfere with the easement in any way. If any improvement is installed, built, or placed within the easement, Grantor bears the risk of loss or damage to those improvements resulting from the exercise of the easement rights and the City is not responsible to repair, replace, maintain, indemnify or reimburse Grantor for any damage or loss. Grantor shall pay for any costs which Grantee incurs as a result of Grantor burdening the easement in any way.

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the Grantee, its successors and assigns.
