Restrictive Covenant

WHEREAS, certain Sites (as defined in Exhibit B) are located within the Property.

NOW THEREFORE, pursuant to Utah Code 9-8a-101 et. seq. and Utah Administrative Code R850-60-100 et. seq., SITLA hereby declares as follows and causes this Restrictive Covenant to be entered into and recorded against the Property:

1. Restrictive Covenant. SITLA hereby subjects the Property and all future owners to the restrictions and covenants set forth on Exhibit B attached hereto and made a part hereof. Hereafter, all portions of the Property shall be held, owned, sold, conveyed, transferred, occupied, leased, rented, encumbered, and used subject to this Restrictive Covenant and the restrictions described herein, all of which shall constitute covenants that run with, touch and concern, and are binding upon the land and all future owners of all or any portion of the Property.

EXHIBIT B

Restrictive Covenant Dated November 7, 2023

Archaeological Deed Covenant

The areal limits of those portions of archaeological sites 42Ws1802, 42Ws1803, 42WS3631 and 42WS3709 on file with the Utah Division of State History and SITLA (referred to as the "Sites") located within the Property, are hereby subject to the following restrictions hereinafter set forth, which are a covenant running with the land in perpetuity and which shall be binding between SITLA and each and every purchaser and future owner, their heirs, successors and assigns (referred to collectively as "Purchaser"). This covenant protects the Site and its setting and requires a Purchaser to seek approval from SITLA before conducting any ground-disturbing activities within the Sites. Purchaser may not collect artifacts from the Sites, or allow anyone else to collect such specimens, as ownership of same is reserved to SITLA. In addition:

- 1. Ownership of all archaeological contexts, data, artifacts, specimens, structural remains, and archaeological features and deposits is reserved and shall remain in SITLA.
- 2. For all activities conducted within the Sites, Purchaser shall comply with the Utah Antiquities Act, *Utah Code Annotated* § 9-8a-301 et seq. and § 9-8a-404, as amended, or any amending or replacing legislation, as if SITLA held title to the Site, including but not limited to:
 - A. Prior to commencing any undertaking (as defined in *Utah Administrative Code* rule R850-60-200) within the limits of the Sites, the Purchaser shall consult with SITLA and seek approval for the proposed undertaking.
 - B. Approval shall be subject to the archaeological contexts, data, artifacts, specimens, structural remains, features and deposits contained in the Sites being preserved, recovered, or otherwise treated in a manner satisfactory to SITLA.
 - C. Purchaser shall provide SITLA with all collections (i.e., specimens, unprocessed samples, notes and photographs) resulting from archaeological investigations at the Sites, and all subsequent data analyses and reports.
- 3. SITLA may, in its sole discretion, release the restrictive covenant in part or in its entirety if SITLA determines, in consultation with the Utah Division of State History, that an appropriate level of data recovery has occurred.
- 4. The restrictive covenant is for the benefit of the beneficiaries of the subject lands. The SITLA and/or the Utah Division of State History may monitor compliance with, seek enforcement of, and be entitled to enjoin any violation of the restrictive covenant and to recover damages caused by the violation.

- 5. SITLA reserves the right of access in perpetuity across the Property to the Sites within the Property for the purpose of monitoring compliance with this covenant or for facilitation of archaeological research within the Sites.
- 6. SITLA reserves the right, but does not covenant, to conduct archaeological investigations at the Sites, along with a right of access for the same, but does not covenant to cause any release of the restrictive covenant pursuant to paragraph 3, above.
