DECLARATION OF ANNEXATION OF SHOOTING STAR PHASE 5 SUBDIVISION

This Declaration of Annexation ("Annexation") is made effective this 19th day of September, 2024 by Ivory Southern, LLC ("Declarant").

RECITALS

- A. The Plat for Shooting Star Phase 1 Subdivision was recorded on December 19, 2018 as Doc. No. 20180050003 (the "Phase 1 Plat").
- B. The Declaration of Covenants, Conditions, Restrictions, For Shooting Star Subdivision was recorded in the office of the County Recorder of Washington County, Utah on December 19, 2018 as Doc. No. 20180050004 (the "Declaration") by Western States Ventures, LLC, which was identified as the Declarant.
- C. The Declaration of Annexation of Shooting Star Subdivision Phase 2 was recorded in the office of the County Recorder of Washington County, Utah on January 12, 2021, as Doc. No. 20210002424 (the "Phase 2 Annexation").
- D. The Declaration of Annexation of Shooting Star Subdivision Phase 3 was recorded in the office of the County Recorder of Washington County, Utah on March 4, 2021, as Doc. No. 20210015337 (the "Phase 3 Annexation").
- E. Pursuant to Article X, Western States Ventures, LLC executed an Assignment of Declarant's Rights assigning its Declarant rights to Ivory Southern, LLC which was recorded in the office of the County Recorder of Washington County, Utah on October 18, 2022, as Doc. No. 20220046941 (hereinafter "Assignment").
- F. The Declaration of Annexation of Shooting Star Subdivision Phase 4 was recorded in the office of the County Recorder of Washington County, Utah contemporaneously with the recording of this Declaration of Annexation on September <u>25</u>, 2024 as Doc. No. 2024 <u>0030106</u> (the "Phase 4 Annexation").
- G. Declarant desires and intends that Shooting Star Subdivision Phase 5 ("Shooting Star Phase 5"), which is more particularly described in Exhibit A attached hereto and incorporated herein (the "Shooting Star Phase 5 Property"), be subject to the Declaration and be part of the Property which shall be held, sold and conveyed subject to the provisions of the Declaration, which

are for the purpose of protecting the attractiveness and character of the Property and which shall run with the land including the Shooting Star Phase 5 Property. This Declaration shall be binding on all parties having any right, title or interest in the Shooting Star Phase 5 Property, or any part thereof, and shall inure to the benefit of the aforementioned parties and their successors and assigns. The Declaration shall run with the land set forth in Exhibit A.

NOW, THEREFORE, Declarant hereby declares, covenants and agrees as follows:

ANNEXATION

This is a Declaration of Annexation prepared pursuant to Article IX of the Declaration, and with the consent of the undersigned.

Shooting Star Subdivision Phase 5 consists of Lots 185-191, 205, and 306-314, SHOOTING STAR SUBDIVISION PHASE 5, according to the Official Plat thereof, on file in the Office of the Recorder of Washington County, State of Utah (the "Shooting Star Phase 5 Lots").

Declarant intends and hereby subjects all of the property described in Exhibit A, including the Shooting Star Phase 5 Lots and the associated Common Area and Limited Common Area, if any, to the terms of the Declaration, as amended from time to time, and further declares that the Shooting Star Phase 5 Property shall be annexed to and become subject to the Declaration, which, upon recordation of this Declaration of Annexation, shall constitute and effectuate the expansion of Shooting Star Subdivision, making the real property described in Exhibit A subject to the Declaration and the functions, powers, rights, duties and jurisdiction of the Association. The Shooting Star Phase 5 Lots and the Common Area and Limited Common Area are located on the following described property in Washington County, State of Utah, including Lots, Common Area and Limited Common Area as set forth on the Plat filed for Shooting Star Phase 5:

The Declarant hereby consents to the annexation of the Shooting Star Phase 5 Property into Shooting Star Subdivision and further declares that the Shooting Star Phase 5 Property shall hereafter be held, sold, conveyed, encumbered, leased, used, occupied and improved as part of the property subject to the Declaration, as amended, and all protective covenants, conditions, restrictions and equitable servitudes set forth in the Declaration, as amended from time to time, the terms of which are deemed incorporated herein by this reference, and to the jurisdiction of the Association and entitled to all rights and privileges afforded therein. The covenants, conditions and restrictions of the Declaration are intended to, and shall in all cases run with the, title of the land described in Exhibit A, and be binding upon the successors, assigns, heirs, lien holders, and any other person holding any interest in the Shooting Star Phase 5 Property, and shall inure to the benefit of all other lots that are subject to the Declaration, as amended from time to time. The covenants, conditions and restrictions of the Declaration, as amended, shall be binding upon the homeowners association and the Declarant as well as their successors in interest, and may be enforced by them or by an owner of a Lot to the extent provided in the Declaration.
