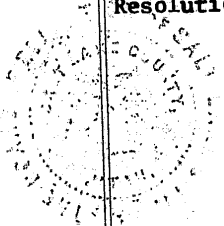
RIGHT OF WAY DEED

BOARD OF EDUCATION OF SALT LAKE CITY, a public corporation, Grantor, for a valuable consideration, receipt of which is hereby acknowledged, does hereby grant, bargain and sell to H. AUSTIN BELNAP and ROBERT E. CAMERON, Grantees, a non-exclusive right of way over, upon and across the following described real property located in Salt Lake City, Salt Lake County, State of Utah, to wit:

Commencing at a point 115.5 feet East of the Northwest corner of Lot 5, Block 23, Plat "A" Salt Lake City Survey and running thence East 25 feet, thence South 115 feet, thence West 25 feet, thence North 115 feet to the point of beginning.

Said right of way shall be appurtenant to the real property of the respective Grantees adjoining the said right of way on the East and on the West. The above described premises shall be paved and maintained by Grantees and shall remain open and unobstructed for the use and benefit of Grantor and its employees at all times.

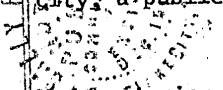
