WHEREAS the District has previously voted to approve the name change; and

WHEREAS the Commission has complied with the requirements to approve the name change including holding a public hearing; and


WHEREAS the Commission desires to approve the proposed name change from the Cedar Mountain Fire Protection District to the Cedar Mountain Service District;

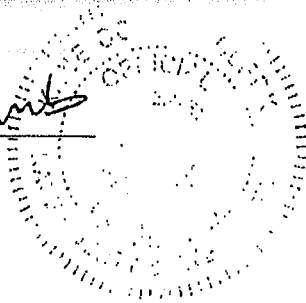


1. The Cedar Mountain Fire Protection District is henceforth to be known as the Cedar Mountain Service District.


