SECOND AMENDMENT TO THE CONDOMINIUM DECLARATION

FOR

CALL MEADOWS PUD

On July 18, 2002 the Condominium Declaration for Call Meadows PUD Phase 1 (the "Declaration") was recorded with the Davis County Recorder as Entry No. 1770843 in Book No. 3087 at Pages 212 through 235.

Pursuant to Section 16.02 of the Declaration and in accordance with Section 57-8-13.2 of the Utah Code Annotated, Declarant (Pages Place L.C.) hereby excersizes its right to further amend the Declaration by creating additional Units within a portion of the Convertible Land identified in the Declaration. The Legal description of the Convertible Land which is hereby converted is identified in Exhibit A attached hereto, and shall hereinafter be referred to as Phase 3 of the Call Meadows PUD. The TWENTY ONE (21) additional Units shall be designated as Building 11 Units A through D, Building 12 Units A through E, Building 13 Units through d, Building 14 Units A through D and Building 15 Units A through D, Bountiful, Utah address.

Pursuant to the Declaration, the additional twenty one (21) Units associated with Phase 3 shall be subject to all the provisions of the Declaration as if they were part of the original Property and Project. The new allocation of shared Common Expenses among the fifty-nine (59) Units within the total Project are set forth in Exhibit B attached hereto and made a part hereof.

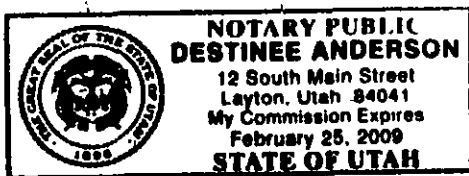
