AMERICAN FORK CITY CORPORATION, a corporation of the State of UTAH, Grantor, of AMERICAN FORK, County of UTAH, State of UTAH, hereby CONVEYS AND WARRANT to the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum of (\$10.00) TEN Dollars, and other good and valuable considerations, the following described parcel of land in UTAH County, State of Utah, to-wit:

A parcel of land in fee, being part of an entire tract of property, situated in the Southeast quarter of the Southwest quarter of Section 15, and in the Northeast quarter of the Northwest quarter of Section 22, Township 5 South, Range 1 East, Salt Lake Base and Meridian, to facilitate the construction of a State Road known Project No. S-I15-6(175)245, and further described as follows:
