08-10-2022 Ruling Entry - RULING AND ORDER RE MOTION TO COMPEL MED

Judge: SCOTT, LAURA

Before the court is Defendants' SMH Builders Incorporated and 968 Washington, LLC [Defendants] Motion to Compel Mediation [Motion to Compel], which was filed on July 22, 2022.

Plaintiff filed the Complaint on May 5, 2021. The Defendants filed Answers, Counterclaims, and Crossclaims. A Notice of Event Due Dates was issued on June 4, 2021, which set May 18, 2022 as the deadline for completion expert discovery and ADR (unless exempt). The parties have stipulated to four extensions of the deadlines. Pursuant to the Fourth Stipulated Statement to Extend the Standard Fact Discovery Deadline filed on July 28, 2022, the parties stipulated to extending standard fact discovery to October 22, 2022, with all other deadlines recalculated accordingly.

Pursuant to the Motion to Compel, Defendants ask the Court to order Plaintiff to mediate this case prior to the Rule 30(b)(6) depositions of Defendants. Plaintiff opposes the Motion to Compel on the grounds that [1] it has sought a good faith settlement offer from Defendants but they have refused to make any offer; and [2] it needs to take the depositions in order to gather relevant information for their negotiating position. Consequently, at this juncture, Plaintiff believes mediation would be a waste of time and resources.

After considering the procedural history of the case and the arguments of the parties, the Court DENIES the Motion to Compel without prejudice. Specifically, while the Court will require the parties to engage in good faith mediation prior to setting the case for trial as required by Rule 4-510.05 of the Utah Rules of Judicial Administration, the Court declines to order that mediation take place prior to the scheduled Rule 30(b)(6) depositions for the reasons set forth in Plaintiff's opposition and because the deadline for completion of the ADR requirement per the Notice of Event Due Dates is the deadline for completion of expert discovery.

However, the Court reminds the parties that it has not waived the ADR requirement and is unlikely to do so. Consequently, they must comply with the requirement by the deadline - i.e., the deadline for completion of expert discovery - and no trial date will be set until they have done so.

SO ORDERED.
