NOTICE OF ADOPTION OF REDEVELOPMENT PROJECT AREA PLAN ENTITLED "500 WEST REDEVELOPMENT PROJECT AREA PLAN" AND DATED AUGUST 2005

1) A Description of the Land Within the 500 West Redevelopment Project Area.

Beginning at a point located South 00°45'28" East along the section line 934.33 feet and West 206.94 feet from the northeast corner of Section 36, Township 2 North, Range 1 West Salt Lake Base and Meridian, said point being the POINT OF BEGINNING; thence along the southeasterly right-of-way boundary of State Hwy 68 North 26°57'57" East 86.37 feet to the Woods Cross City Boundary; thence the following 7 courses along the Woods Cross City Boundary, which is also the southeasterly right-of-way boundary of State Hwy 68: North 26°57'57" East 63.95 feet, North 26°55'13" East 216.46 feet, North 29°16'31" East 75.66 feet, North 28°46'04" East 58.18 feet, North 24°19'05" East 376.40 feet, North 28°32'53" East 219.71 feet, North 26°40'31" East 1346.19 feet; thence the following 9 courses continuing along the Woods Cross City Boundary, which is also the southerly right-of-way boundary of 1500 South Street and projected: North 89°47'28" West 146.80 feet, North 89°47'10" West 71.18 feet, South 89°20'37" West 102.98 feet, North 88°24'37" West 87.02 feet, South 81°44'12" West 10.93 feet, North 89°39'21" West 223.69 feet. 
