

2. **214590 UTAH POWER & LIGHT COMPANY
POWER LINE EASEMENT**

STATE ROAD COMMISSION OF UTAH, an agency of the State of Utah, Grantor, hereby grants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, an easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and 11 guy anchors and 13 poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor in Davis County, Utah, along a line described as follows:

Beginning at an existing pole on the Grantors' land which is 21 feet and 837 feet east, more or less, from the south one quarter corner of Section 11, T. 1 N., R. 1 W., S.L.M., thence N. 89° 44' E. 485 feet, thence N. 1° 11' E. 1050 feet, thence N. 12° 49' E. 1265 feet, thence N. 6° 47' E. 310 feet, thence N. 13° 44' E. 410 feet, thence N. 2° 06' W. 231 feet, thence N. 20° 1' E. 20.5 feet to an existing pole on said land and being in the S 1/2 of the SE 1/4 of the NE 1/4 of the SE 1/4 of the NE 1/4 of said Section 11.

Also, beginning at a pole on the Grantors' land at a point 1123 feet west, more or less, from the east one quarter corner of Section 11, T. 1 N., R. 1 W., S.L.M., thence S. 45° CO' E. 196 feet to a point described centerline, thence continuing S. 45° CO' E. 222 feet to the right of way line of said land and being in the NW 1/4 of the SW 1/4 of said Section 11.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto.


