GRANT AND CONFIRMATION OF EASEMENT

[Document 1]

THIS GRANT AND CONFIRMATION OF EASEMENT ("Easement") is made and entered into this 20 day of August, 1999, by VEIGH X. CUMMINGS, also known as VEIGH CUMMINGS, TIMBER LAKES CORPORATION, a Utah corporation, which also acquired title as TIMBERLAKES CORPORATION and TIMBERLAKES INC., a Utah corporation, VEIGH CUMMINGS, doing business as CC INVESTMENTS, VEIGH CUMMINGS, doing business as VXC INVESTMENT, referred to jointly and severally as ("Grantors") and the CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF LATTER-DAY SAINTS, a Utah corporation sole, hereinafter referred to as ("Grantee") and is based upon the following:

RECITALS

- A. Grantors have sold to Grantee the property described on <u>Exhibit "A"</u>, attached hereto and incorporated herein by reference, hereinafter referred to as (the "Property").
- B. It was a condition to the purchase of the property by Grantee that Grantee have access to its property for pedestrian, vehicular and utility access on, over, under and across the streets of the various plats in the Timber Lakes subdivision as described on Exhibit "B", attached hereto.
- C. Pursuant to: (i) an Agreement for Right of Way and Easement between Veigh Cummings, Timber Lakes Incorporated and Timber Lakes Property Owners Association, dated June 16, 1978 and recorded in the records of the Summit County Recorders Office, as Entry No. 113216 or June 16, 1978 in Book 118, at Pages 770 to 1774, and (ii) a Declaration of Protective Covenants, Conditions, Restrictions and Management Policies for Timber Lakes Estates, executed by Timber Lakes Corporation, as Declarant and accepted by the Timber Lakes Owners Association, dated July 8, 1980 and recorded in the Records of the Wasatch County Recorder, as Entry No.

120374 on July 29, 1980 in Book 134 at Pages 275 through 298, and (iii) a Memorandum of Agreement by and between Timber Lakes Property Owners Association and Timber Lakes Corporation, dated July 13, 1987 and recorded July 16, 1987 as Entry No. 142886 in Book 192 at Page 715 of the Wastach County Records, Grantors reserved certain easement rights over the Timber Lakes subdivision roads.

D. Grantors now desire to confirm and grant to Grantee the easement rights obtained pursuant to the documents referred to in Item C above for the benefit of Grantee's property described on Exhibit "A."

NOW, THEREFORE, for Ten Dollars and No/100 (\$10.00) and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. Grantors hereby grants to Grantee and confirms in Grantee, an easement over the roadways in the Timber Lakes subdivision reserved by Grantee in the above-referenced agreements and hereby confirms that the property purchased by Grantee, and described on Exhibit "A" was part of the "adjacent lands" described in those documents. Grantors reserve the right to also use said easements.
- 2. Grantors hereby further designate Grantee and the property described on Exhibit "A," as entitled to all of the benefits of those easements pursuant to Grantor's power to so declare set forth in the above-referenced documents.
- 3. Grantors further confirm and warrant to Grantee that Grantee shall have no obligation to maintain and operate or install any utility systems in connection with its use and enjoyment of the easements referred to herein.
- 4. This Easement embodies the entire agreement between the parties regarding the subject matter of this Easement, and cannot be modified except by the written agreement of such parties.
