his wife, Grantors, of Weber County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and 23 anchors, 9 poles, 1 - 2-pole tower and 3 - 3-pole towers exceptes, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantors, in Weber County,

Utah, along a line described as follows:

Beginning at fence on west boundary line of grantors' land at a point 340 feet north and 355 feet east, more or less, from the south quarter corner of Section 18, T.5 N., R.1 W., S.L.B.& M., thence running N.53°30'E. 49 feet, thence N.73°16'E. 445 feet, thence N.59°34'E. 300 feet, more or less, to east boundary line of said land at west right of way fence of U.P.R.R.Co.; also beginning on west boundary line of grantors! land at a point 275 feet north and 425 feet east, more or less, from the south quarter corner of said Section 18, thence running N.53°24'E. 410 feet, more or less, thence N.59°41'E. 360 feet, more or less, to east boundary line of said land at west right of way fence of U.P.R.R.Co.; also beginning on west boundary line of grantors' land at a point 230 feet north and 470 feet east, more or less, from the south quarter corner of said Section 18, thence running N.54°02'E. 355 feet, thence S.85°56'E. 385 feet to west right of way fence of U.P.R.R. on east boundary line of said land; also beginning on west boundary line of grantors! land at a point 190 feet north and 525 feet east, more or less, from the south quarter corner of said Section 18, thence running N.55°07'E. 215 feet, more or less, thence S.83°57'E. 504 feet to west right of way fence of U.P.R.R. on east boundary line of said land; also beginning on west boundary line of grantors' land at a point 145 feet north and 570 feet east, more or less, from the south quarter corner of said Section 18, thence running N.56°14'E. 190 feet, more or less, thence S.83°58'E. 493 feet to west right of way fence of U.P.R.R. on east boundary line of said land; and being in the SW 1/4 of the SE 1/4 of said Section 18.
