RIGHT OF WAY AGREEMENT FOR
SALT LAKE CITY SUBURBAN SANITARY DISTRICT PIPE LINE

Ray E. Nelsen and Mildred C. Nelsen, his wife,
of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant
to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing

under and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar and other
Sewer installed at no cost
consideration. to property owner. DOLLARS (\$ 1.00) receipt of which is hereby

acknowledged, a right of way and easement for the purpose of digging a trench along said right
of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through
and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:
Com at S W Cor Lot 2, Blk 13, 10 Acre Plat "A" B. F. S. N 55.9 rds; E 12 rds; S 55.9 rds;
W 12 rds to beg.
Also Com at S W Cor Lot 2, Blk 3, Sec 36, T15, R1W, S L Mer. N 0° 05' W 55.6 rds; S 89° 57' E
3.54 rds; E 55.6 rds; N 89° 57' W 3.54 rds to beg. Being in Lot 3, Blk 13, Ten Acre Plat "A"
Big Field Survey.

the center line of said pipe shall extend through and across the above land and premises on a line
described approximately as follows:
Com at a pt on the west property line 7 ft. North fr the S W Cor of above described
property, and running thence East 15.54 rds parallel to and 7 ft North of the South
property line. Easement to consist of the South 10 feet of the above property.

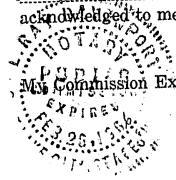
TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so

right of way, and to maintain, operate, repair, remove or replace the same. The said Grantors

granted to the said Grantee.
