Upon consideration of the Application for Informal Probate of Will and Informal Appointment of Personal Representative filed by Chad Michael Seeley on October 17, 2022, the clerk of the court finds that:

1. 1. The application is complete.
2. 2. Applicant has made oath or affirmation that the statements contained in the application are true to the best of applicant's knowledge and belief.
3. 3. Applicant appears from the application to be an interested person as defined by the Utah Uniform Probate Code.
4. 4. The decedent, Richard Putman Seeley aka Richard P. Seeley aka Richard Seeley, died on September 5, 2022, at the age of 79 years.

5. 5. On the basis of the statements in the application, venue is proper.
6. 6. Any required notice has been given or waived.
7. 7. The original of the decedent's will, dated May 29, 2018, was presented to the court for electronic storage and electronic filing and is now in the possession of the Applicant.
8. 8. On the basis of the statements in the application, the will to which the application relates is not part of a known series of testamentary instruments (other than wills or codicils), the latest of which does not expressly revoke the former.
9. 9. On the basis of the statements in the application, neither the will to which the application relates nor any other will of the decedent has been the subject of a previous probate order in this state.
10. 10. On the basis of the statements in the application no personal representative has been appointed in this state or elsewhere.
11. 11. It appears from the application that the time limit for informal probate of wills has not expired.
12. 12. The application does not indicate the existence of a possible unrevoked testamentary instrument which may relate to property subject to the law of this state, and which is not filed for probate in this Court.
13. 13. Based on the statements in the application, the person whose appointment as personal representative is sought is qualified to act as personal representative and has priority entitling said person to the appointment.
14. 14. Bond is not required.

THEREFORE:

15. 1. The will of the decedent, dated May 29, 2018, is hereby informally probated.

16. 2. Chad Michael Seeley is hereby appointed personal representative of the estate of the decedent, to act without bond.

17. 3. Upon qualification and acceptance, Letters Testamentary shall be issued.
