The court decrees:

Divorce

1. **Amy Jean Bogner** is granted a divorce based on her Affidavit of Jurisdiction and Grounds. The divorce will become final upon entry of the divorce decree.

2. **Amy Jean Bogner** and **Geoffrey Bogner** do not have any children together.
