RIGHT OF WAY AGREEMENT FOR
SALT LAKE CITY SUBURBAN SANITARY DISTRICT PIPE LINE

Ruth R. Jones and Robert F. Jones Her husband

of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar and other consideration. District to pay entire cost of line construction.

DOLLARS (\$ 1.00) receipt of which is hereby acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in:

Com 1342 ft S & 557 ft W fr N E Cor of Sec 35, T1S, R1E, S L Mer. N 70°15' W 64 ft; N 1 1/2°E 26.4 ft; N 80°W 178 ft; N 377.3 ft to Mill Creek, S 77°06' E 244 ft; S 407 ft to beg. 2 Ac.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:

Commencing at an existing Manhole, which point is 16 ft North of an existing fence running to the east and 7 ft west of an existing fence running to the North, thence North 122 ft M or L, 7 feet west of and parallel to fence, thence S 83°20' E 240 ft to the east boundary of the above described property.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantors.. to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.

Note: Rocks must be moved from surface and top soil must be moved back and replaced back over trench area. Also fences, irrigation ditches or other structures are to be replaced.
