Land of the Grantor located in the Southwest Quarter of Section 24, Township 5 South, Range 1 East, Salt Lake Base and Meridian;

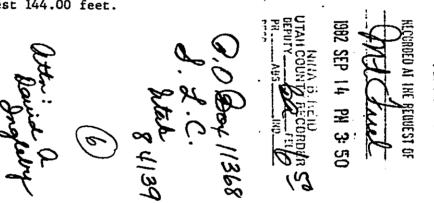
