The Undersigned Grantor (and each and all of them if more than one) for and in consideration of Ten and no/100 - - - - -dollars (\$10.00) in hand paid by the Grantee, the receipt whereof is hereby acknowledged, hereby grants, bargains and conveys unto The Mountain States Telephone and Telegraph Company, a Colorado corporation, 931 14th Street, Denver, Colorado, 80202, Grantee, its successors, assigns, lessees, licensees and agents, a Right-of-Way Easement and the right to construct, operate, maintain and remove such communication and other facilities, from time to time, as said Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to-wit: Commencing 8 rods West of the Northeast corner of Lot 6, Book 23, Plat A, Salt Lake City Survey, the South 10 rods; thence west 32 feet, thence North 5 feet, thence East 27 feet; thence North 160 feet; thence East 5 feet to beginning.

Also commencing 128.5 feet East of the Northwest corner of Lot 5, Book 23, Plat A, Salt Lake City Survey, thence South 10 rods; thence East 45 feet; thence North 5 feet; thence West 40 feet; thence North 160 feet; thence West 5 feet to beginning.

Also commencing 5 rods South of the Northwest Corner of Lot 7, Block 23, Plat A, Salt Lake City Survey, thence North 30 feet; thence East 5 feet; thence South 30 feet; thence West 5 feet to beginning.

TOGETHER with the right of ingress and egress over and across the lands of the Grantor to and from the above-described property, the right to clear and keep cleared all trees and other obstructions as may be necessary and the right to permit other utility companies to use the right of way jointly with Grantee for their utility purposes.
