Finding the plea to be entered knowingly and voluntarily with a full understanding of the rights and the consequences, and finding a factual basis for the plea, the Court accepts the plea and holds it in abeyance for a period of 24 months.

PLEA IN ABEYANCE

Defendant's plea is held in abeyance.

Conditions of Agreement:

The parties have reached an agreement. The plea in abeyance agreement is signed and entered into the case.

The defendant shall pay a non-refundable Plea in Abeyance fee to the Court.

The defendant shall have no violation of Federal, State, or Local laws, except minor traffic offenses, for the period of the plea in abeyance.

The defendant must immediately notify the Bountiful City Prosecutor's Office and the court of any change of address. Failure to do so constitutes defendant's waiver of notice and appearance.

PLEA IN ABEYANCE ADDITIONAL CONDITIONS

The plea is held in abeyance for a period of 24 months.

Defendant to complete a domestic violence evaluation and any recommended treatment, paying all costs, and provide proof of completion of both to the Court.

Defendant to complete a substance abuse evaluation and any recommended treatment, paying all costs, and provide proof of completion to the Court.

Defendant may apply for early termination of probation at 12 months if all terms of the plea in abeyance agreement have been met and completed.
