The court decrees:

Divorce

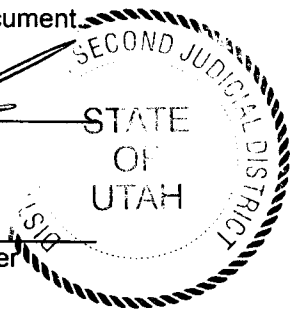
