The court decrees:

## Divorce

1. **Meredith Lynn Hodapp** is granted a divorce based on her Affidavit of Jurisdiction and Grounds. The divorce will become final upon entry of the divorce decree.

# Children

2. **Meredith Lynn Hodapp** and **Shane Gregory Hodapp** are the legal parents of the following children (Utah Code 78B-15-101 et seq.). This court has jurisdiction to make orders about these children.

a. Olivia Grace Hodapp Born 02/27/2006

## Children - custody

3. The parties are awarded Joint Legal and Joint Physical Custody of their children. The children will live in **Meredith Lynn Hodapp's** home **183** overnights each year and in **Shane Gregory Hodapp's** home **182** overnights each year. The court approves the following Parenting Plan.

# Parenting Plan parent-time

Parent-time will be equal between the parties. **Meredith Lynn Hodapp** will have parent-time starting Monday morning and ending Wednesday morning. **Shane Gregory Hodapp** will have parent-time starting Wednesday morning and ending Friday morning. Each parent will alternate weekends having parent-time starting Friday morning and ending Monday morning. Transfers for parent-time will take place at the time the child's school begins or if school is not in session at 9:00 a.m., if the parent picking up the child is to be available with the children during the day.

The chart below shows how this schedule will function.

Each year, a parent may choose two consecutive weeks to exercise uninterrupted parent-time during the summer when school is not in session. A parent will choose at least 30 days before the day on which the chosen two-week period begins. In even numbered years, **Meredith Lynn Hodapp** may choose at any time and **Shane Gregory Hodapp** may choose after May 1. In odd numbered years, **Shane Gregory Hodapp** may choose at any time and **Meredith Lynn Hodapp** may choose after May 1. The two consecutive weeks override all holidays except for Mother's Day and Father's Day.

# Parent-time for special occasions

4. The parents will follow the schedule for special occasions below. If there is more than one child and the children's school schedules vary for purpose of a holiday, at the option of the parent exercising the holiday or the parent's half of the holiday, the children may remain together for the holiday period beginning the first evening that all children's schools are let out for the holiday and ending the evening before any child returns to school. # Decision-making

6. The following applies to the Parenting Plan:

- Each parent will make day-to-day decisions for the children during the time they are caring for the children.
- Either parent may make emergency decisions affecting the health or safety of the children. A parent who makes an emergency decision must share the decision with the other parent as soon as reasonably possible.

**Joint decision-making.** The parents will share responsibility for making major decisions about the children. If there is a disagreement, the parents will resolve the dispute as provided in the Resolving disputes section below.

## **Education Plan**

7. The school the children will attend is based on **Shane Gregory Hodapp's** home residence.

- 8. Meredith Lynn Hodapp has authority to check the children out of school.
- 9. Shane Gregory Hodapp has authority to check the children out of school.
- 10. Meredith Lynn Hodapp has access to the children during school.

11. Shane Gregory Hodapp has access to the children during school.

# Communication with each other

12. Parents will communicate with each other by any method.

# Communication with the children

13. The parents agree they will:

- provide age-appropriate help to the children to communicate with the other parent.
- give the children privacy during their communication with the other parent. The parents will not interfere with or monitor communication between the children and the other parent.

Parents and children may communicate with each other whenever the children choose.

By any method

# Records and information sharing

14. Both parents will have access to records and the ability to consult with providers regarding education, child care, and health care.

# Travel by the children

15. During their parent-time, the parent may consent for the children to travel with a sports team, religious group, school group, relatives, friends, by themselves, or with others.

# Relocation of a parent (Utah Code 30-3-37)

16. If either parent moves more than 149 miles from the other, the moving parent must give the non-moving parent a written Notice of Relocation. The notice must be sent at least 60 days before the planned move.

The written Notice of Relocation must include:

- Information about the move;
- A proposed parent-time schedule; and
- A statement that the parents will not interfere with the other parent's parent-time.

If the moving parent does not give the non-moving parent a Notice of Relocation, the

moving parent will be in contempt of the Court's order.

17. If either parent lives more than 149 miles away from the other, or if the parents live a different countries, parent-time will be as the parties agree. If they are unable to agree, the following will be the minimum parent-time for the noncustodial parent:

Relocation Schedule (Utah Code 30-3-37)

a. in years ending in odd number, the minor children will spend the following holidays with the noncustodial parent:

i. Thanksgiving holiday beginning Wednesday until Sunday; and ii. spring break, if applicable, beginning the last day of school before the holiday until the day before school resumes;

b. in years ending in an even number, the minor children will spend the following holidays with the noncustodial parent:

i. the entire winter school break period; and

ii. the fall school break beginning the last day of school before the holiday until the day before school resumes; and

c. extended parent-time equal to ½ of the summer or off-track time for consecutive weeks. The children will be returned to the custodial home no later than seven days before school begins. This week will be counted when determining the amount of parent-time to be divided between the parents for the summer or off-track period. The parties will mutually agree on this extended time each year. If they are unable to agree, the noncustodial parent will select the dates for the extended time period.

d. One weekend per month at the option and expense of the noncustodial parent. The noncustodial parent's monthly weekend entitlement is subject to the following restrictions.

i. If the noncustodial parent has not designated a specific weekend for parent-time, the noncustodial parent will receive the last weekend of each month unless a holiday assigned to the custodial parent falls on that particular weekend. If a holiday assigned to the custodial parent falls on the last weekend of the month, the noncustodial parent will be entitled to the next to the last weekend of the month.

ii. If a noncustodial parent's extended parent-time or parent-time over a holiday extends into or through the first weekend of the next month, that weekend will be considered the noncustodial parent's monthly weekend entitlement for that month.

iii. If a child is out of school for teacher development days or snow days after the children begin the school year, or other days not included in the list of holidays in Subsection (5) and those days are contiguous with the noncustodial parent's monthly weekend parent-time, those days will be included in the weekend parent-time.

e. The custodial parent is entitled to all parent-time not specifically allocated to the noncustodial parent.

18. If either parent lives more than 149 miles away from the other or the parents live in separate countries, costs for the children's travel expenses for parent-time will be shared equally.

If a parent has been found in contempt for not being current on all support obligations, and they do not have primary physical care of the child, they will be responsible for the child's related travel expenses.

Reimbursement the child's travel expenses must be made within 30 days of receipt of documents detailing those expenses.

# Changing the plan

19. This plan remains in effect until changed. A change must be agreed to by both parents and in the following manner:

• Major or permanent changes must be in writing, but minor or temporary changes can be made orally.

# Resolving disputes

20. If the parents need to resolve a dispute regarding the children, they will discuss the issues in good faith and try to reach an agreement based on what is best for their children. If the parents are unable to agree, they will go to the following before bringing the issue to the court: **Counseling**

Military service by a parent (Utah Code 78B-20-4)

22. Neither parent is a servicemember.

23. A joint physical custody arrangement may result in denial of cash assistance under

the Employment Support Act, Title 35A, Chapter 3, of the Utah Code.

Income: Meredith Lynn Hodapp (Utah Code 78B-12-203)

24. **Meredith Lynn Hodapp's** gross monthly income for child support purposes is **\$6,125.00**. Her base child support amount using the joint custody calculation is **\$0.00** per month. She receives the following gross monthly income:

a. **Meredith Lynn Hodapp** is employed at **Northrop Grumman Corporation**. She earns **\$6,125.01** gross (pre-tax) monthly income working a 40-hour a week job or less.

Income: Shane Gregory Hodapp (Utah Code 78B-12-203)

25. Shane Gregory Hodapp's gross monthly income for child support purposes is
\$7,861.00. His base child support amount using the joint custody calculation is \$89.00 per month. He receives the following gross monthly income:

He receives the following gross monthly income:

a. **Shane Gregory Hodapp** is employed at **Rockexotica.** He earns **\$7,861.29** gross (pre-tax) monthly income working a 40-hour a week job or less.

Child Support (Utah code 78B-12-202 et seq.)

26. Shane Gregory Hodapp will be ordered to pay child support to Meredith Lynn Hodapp as follows:

a. **\$89.00** per month base support. This amount complies with the Utah Child Support Act.

Unless the Court orders otherwise, support for each child ends when:

- a child turns 18 or has graduated from high school during the child's normal and expected year of graduation, whichever occurs later, or
- a child dies, marries, becomes a member of the United States armed forces, or is emancipated (Utah Code 78A-6-801).

27. Child support payments will start the month immediately following entry of the order. The payment schedule will be:

• one half by the 5<sup>th</sup> day of each month, and

• the other half by the 20<sup>th</sup> day of each month.

Child support not paid by the 5<sup>th</sup> day of the month is past due on the 6<sup>th</sup> day of the month. Child support not paid by the 20<sup>th</sup> day of the month is past due on the 21<sup>st</sup> day of the month. If the Office of Recovery Services is used to collect support, their payment schedule will be followed.

28. The issue of past-due child support may be decided by future court or administrative action.

29. The parties must notify each other within 30 days of any change in their income.

30. The parties can ask to change this child support order by motion after three years from the date of its entry if:

- there is a difference of 10% or more between the amount previously ordered and the new amount of child support under the Utah child support guidelines,
- the difference is not temporary, and
- the amount previously ordered was not a deviation from the child support guidelines.

(Utah Code 78B-12-210(8)).

If the children receive TANF funds at the time an adjustment is sought, ORS will review the order and ask the court to adjust the amount if appropriate. (Utah Code 26b-9-211).

31. The parties can ask to change this child support order at any time by petition if there has been a substantial change in circumstances because of material changes in:

- custody;
- the relative wealth or assets of the parties;
- income of a parent of 30% or more;
- the employment potential and ability of a parent to earn;
- the medical needs of the child; or
- the legal responsibilities of either parent for the support of others. (Utah Code 78B-12-210(7) and (9)).

The change must result in a difference of 15% or more between the amount previously ordered and the new amount of child support under the Utah child support guidelines. The difference may not be temporary.

The court can consider natural or adoptive children born after the entry of the decree other than those in common to both parties as part of a request to modify an existing award subject to limitations in the law. (Utah Code 78B-12-210(7)).

# Dependent children for tax purposes

32. **Shane Gregory Hodapp** may claim the parties' children as dependents/exemptions for tax purposes in odd numbered years. **Meredith Lynn Hodapp** may claim the parties' children as dependents/exemptions for tax purposes in even numbered years.

# Child health care (Utah Code 78B-12-212)

33. The parties must provide health care coverage for the medical expenses of the dependent children. Heath care coverage means coverage under which medical services are provided to a dependent child through: fee for service, a health maintenance organization, a preferred provider organization, any other type of private health insurance, or public health care coverage. Utah Code 78B-12-102(13).

The parent who is able to obtain the most affordable medical, hospital, and dental insurance for the dependent children must maintain medical, hospital, and dental care insurance for the dependent children if it is available at reasonable cost. If medical insurance is not available at reasonable cost then both parents must ensure the children have health care coverage. This may require applying for public health care coverage, such as CHIP or Medicaid.

a. If, at any time, a dependent child is covered by the medical, hospital, or dental insurance plans of both parents, the coverage will be as follows:

- Meredith Lynn Hodapp's insurance will be primary coverage.
- Shane Gregory Hodapp's insurance will be secondary coverage.

b. If a parent remarries and that parent's dependent child is not covered by that parent's health, hospital, or dental insurance plan but is covered by a step-parent's plan, the coverage will be as follows:

- Meredith Lynn Hodapp spouse's insurance will be primary coverage.
- Shane Gregory Hodapp spouse's insurance will be secondary coverage.

c. Both parties will equally share the out-of-pocket costs of the insurance premiums.

d. Both parties will equally share all uninsured and unreimbursed medical and dental expenses that are reasonable and necessary. This includes deductibles, co-insurance, and co-payments paid by a party for the dependent children.

e. The party who pays health care expenses must provide the other party written verification of the cost and payment within 30 days.

f. If a party does not follow this order and provide written verification, they may not be able to receive credit for health care expenses or recover the other party's share of the expenses.

g. On or before January 2 of each year, the party ordered to maintain coverage must provide verification of coverage to the other party, and ORS, if they are involved.

h. If there is any change in coverage, within 30 days of the change the party ordered to maintain coverage must notify the other party and ORS, if they are involved.
