

LEO GREEN SHOPPING, Inc., a Utah corporation, Grantor, of Layton, Utah, here-  
 by conveys and warrants to MOUNTAIN FUEL SUPPLY COMPANY, a Utah corporation,  
 Grantee, of Salt Lake City, Utah, its successors and assigns, for the sum of  
 ONE DOLLAR (\$1.00) and other good and valuable consideration, a right of way  
 to lay, maintain, operate and remove pipe lines, with the right of ingress and  
 egress to and from said right of way over and through the following described  
 tract of land in Section 28, Township 4 North, Range 1 West, Salt Lake Base and  
 Meridian, Davis County, Utah:

Beginning at a point on the East of Mountain Fuel Supply Company 10"  
 H.P. natural gas main in Layton, Davis County, State of Utah; said point  
 being South 378.93 feet and East 2,160.45 feet from the Northwest corner  
 of the Northwest quarter of Section 28, Township 4 North, Range 1 West,  
 Salt Lake Base and Meridian, United States Survey, and running thence  
 North 88° 36' 45" East 12.5 feet; thence South 4° 59' 23" West 62.36  
 feet; thence North 43° 07' 15" West 40.04 feet; thence North 4° 59' 23"  
 East 32.28 feet; thence North 88° 36' 45" East 17.5 feet to the point  
 of beginning.

Also, beginning at a point being South 278.45 feet and East 2,178.99  
 feet from the Northwest corner of the Northwest quarter of Section 28,  
 Township 4 North, Range 1 West, Salt Lake Base and Meridian, United  
 States Survey, and running thence South 89° 55' 15" East 10.0 feet; thence  
 South 0° 04' 45" West 52.76 feet; thence North 10° 39' 15" West 53.69  
 feet to the point of beginning.

The said Grantor to fully use and enjoy the said premises except for the  
 purpose hereinbefore granted to the said Grantee, which hereby agrees to pay  
 damages which may arise to lawns, shrubs, crops or fences from the laying, main-  
 taining, operating or removing of said pipe lines; said damage, if not mutually  
 agreed upon, to be ascertained and determined by three disinterested persons,  
 one thereof to be appointed by the said Grantor, its successors or assigns, one  
 by the said Grantee, its successors or assigns, and the third by the two so  
 appointed as aforesaid.

By acceptance of this right of way and easement grant, Grantee hereby quit  
 claims and releases all rights to Grantor's property obtained by virtue of that  
 certain right of way and easement grant dated May 14, 1962, and recorded May  
 28, 1962, by the Davis County Recorder in Book 243, Page 141, Entry No. 236808.
