That 32-foot commercial access which centers at a point directly opposite the center line of said project approximately at Engineer Station 278+56 (78+56 on plans) said point is also approximately N.00°08'15"W. along the Section line 19.76 feet and East 1,357.31 feet from the West 1/4 Corner of said Section.


