AN ORDINANCE OF WEBER COUNTY AMENDING THE UNIFORM ZONING ORDINANCE OF UNINCORPORATED WEBER COUNTY

WHEREAS, the owners of the Property have submitted a conceptual plan showing potential development of the Property; and

whereas, Manufacturing M-1 zoning is consistent and common zoning and character of real property surrounding the Property; and whereas, the proposed zoning County Planning Co WHEREAS, Manufacturing M-1 zoning is consistent and compatible with the existing

WHEREAS, the proposed zoning amendment has been submitted to the Western Weber County Planning Commission for its approval, disapproval, or recommendations;

NOW THEREFORE, the County Legislative Body of Weber County ordains as follows:

The following described real property is zoned Manufacturing M-1, and the 1 zoning map of Weber County shall be amended accordingly:

Beginning at a point on the Westerly right of way line of U.S. Highway 89, 91 and 30-S, said point being 19.36 feet North 0°'58'07" East along the Section line from the Northeast corner of said Section 36; running thence South 33°53'08" East 534.88 feet along said Westerly right of way line; thence South 70°37'03" West 322.65 feet to the Section line; thence South 0°39'48" West 511.00 feet along said Section line; thence South 87°16'48" West 175.08 feet; thence South 64°20'09" West 494.78 feet to the Easterly boundary of Weber Industrial Park Plat "A," Weber County, Utah, also being the Westerly right of way line of the Oregon Short line Railroad Company (O.S.L.R.R.
