

AN ORDINANCE PROVIDING FOR THE VACATION OF CERTAIN ALLEYWAY LOCATED IN BLOCK 17, SOUTH OGDEN FLAT "A", WEBER COUNTY, STATE OF UTAH.

Be it ordained by the Mayor and City Council of the City of South Ogden, Weber County, Utah.

SECTION 1. WHEREAS application has been made by the owners of all the property fronting or abutting that certain alleyway located in Block 17, South Ogden Flat "A", Weber County, Utah, running North and South between 40th and 41st Streets, asking that said alley be declared vacated and the title thereto be returned to the abutting property owners, and it appearing to the Mayor and City Council that neither the public nor any person will be injured if said petition is granted;

NOW, THEREFORE, BE IT ORDAINED BY the Mayor and City Council of South Ogden City, Utah, that the said alley running North and South from 40th to 41st Street in Block 17, South Ogden Flat "A", said alley being sixteen (16) feet wide, be and the same is hereby closed and vacated as a public alley, the land to revert to the abutting property owners as their interests may appear.

BE IT FURTHER ORDAINED that a copy of this ordinance be recorded in the Office of the County Recorder of Weber County, Utah.

SECTION 2. In the opinion of the Mayor and City Council of the City of South Ogden, a public emergency exists in connection with the matters herein contained and it is necessary to the peace, safety and general welfare of the inhabitants of the City of South Ogden that this ordinance become effective immediately.

SECTION 3. There being no newspaper published within the corporate limits of the City of South Ogden, this ordinance shall take effect upon its adoption and posting in accordance with law.

Passed and adopted by the Mayor and City Council of South Ogden, Utah, this 20th day of July 1958.
